1. General Reminders / Notes

2. Attendees were shown the Stadacona Base - A Block

Notes:

- .1 We started on the third floor, and attendees were shown the garbage room, janitorial closets, shower room, laundry room and washrooms.
- .2 It was noted that the second and third floors are identical.
- .3 Attendees were shown the first floor, including the mail room.
