SECTION A - QUESTIONS AND ANSWERS

Question 43

I wish to pose a question regarding submission of electronic copies of bids, referencing Part 3.1 Bid Preparation Instructions.

Point (a) of Part 3.1 indicates that Section I and Section II material is required in two (2) soft copies on CD (as well as in four hard copies).

Point (f) of Part 3.1 indicates that Excel format electronic templates should be included along with the Section I and II soft copies, using CD, USB Key, etc

My question is – May a USB Key/flash drive be used to provide electronic copies of all material, including the material required for Sections I and II, as well as the material relating to the Excel format templates, for purposes of simplicity, convenience and eventual reduction of electronic waste?

Yes, you may submit the electronic version on a USB key instead of a CD.

REASON FOR AMENDMENT

1. To amend **PART 7- 4.1 Period of the Supply Arrangement**

A.1 **Delete Article 4.1 Period of the Supply Arrangement in Part 7** in its entirety and **replace** with the following:

a. The period for awarding contracts under the Supply Arrangement is from date of issuance of the SA to November 30, 2014.
