Under Workstations:

1. It states in sections 3.3,4.3,5.3 and 7.3 that a 15 Amp duplex receptacle is to be installed. Will the wiring to the receptacle already be in place.
No, wiring is not in place. Will be responsibility of the contractor.
2. It states for section 4 -- 3.4 that an HDMI over IP extender must be provided to monitors to the workstation in first floor LAN. Will the integrator be responsible for pulling the wire from room to room.
Yes, contractor will be responsible.

Warranty and Maintenance:

3. In section 4 it states that preventative and corrective maintenance performed by a maintenance contractor other than this contractor after or during the warranty period will not void warranty and labour hardware and software provide by this contractor. Does that include CBSA employee's?
Yes, but only Regional Security employees who have completed the Advanced Milestone Certification.
