I believe Page 11 in the Statement of Requirements has some conflicts with the drawing, I think its related to the Dillon Gatling Guns.

Answer #7:

There are 4 dillon cabinets, please follow the drawing.

Question #8:

Also the bolt storage cabinets need clarifications, 24 bolts per drawer but it should be listed by weapon. A C6 bolt is ten times bulkier than a C7,C8, C9. This would have been so much easier efficient and less expensive to put this in a Vidmar Drawer cabinet.
