Q3- The shredders requested with a 220 volt amp takes 8 weeks from when a PO is issued. Can there be an extension to the delivery time.

A3- The requested delivery time is a “requested time” not a “required time”.

Q4- Under Certifications, since we are part of the supply arrangement and we have already submitted the proper certifications, do we need to resend the certifications. Such as Code of Contact, FCP program, the RCMP Letter for the quoted shredder

A4- This requirement is separate from the Supply Arrangement in question so you must complete all of the necessary certifications indicated in the RFP.
