This Amendment 002 (Addendum #1) is raised to answer potential bidder's questions and to issue changes to the Specifications and the Appendix 1 - Combined Price Form.

The following changes in the tender documents are effective immediately. This addendum will form part of the Contract documents.

Questions from Bidders:

Q1. One of the reasons for the request for previous reports is that the insurance requirements include a need for \$10 million in pollution liability coverage. This seems higher than previous similar as well as larger projects issued by PWGSC recently. Can you kindly indicate why such high coverage is requested given the advertised budget for the project is \$200-\$250K.

A1. The insurance requirement for Contractors Pollution Liability insurance, and maintain it in force throughout the duration of the Contract, in an amount usual for a contract of this nature, but for not less than \$1,000,000 per accident or occurrence and in the annual aggregate.

Q2. Are you aware of a weigh scale that is currently operating in Lower Point to weigh the contaminated soil being sent for disposal/treatment, as required in the tender?

A2. It is up to the bidder to consult with the appropriate supplier/vendor. PWGSC will not endorse a particular product or vendor.

Q3. Is the contaminated soil to be disposed at the local landfill or is it to be treated too? The confusion arises from Sec 02 61 00.02 Page 50 of 55 Sec 1.1.9

A3. Contaminated soil is to be disposed at a facility permitted to accept the material. The facility's permit may require the soil treatment before disposal or may allow direct disposal pending the concentrations of contaminants in the soil and their allowable permit levels. It will be the responsibility of the contractor to ensure all soils are managed and disposed of in accordance with all applicable laws and regulations. It is at PWGSC's discretion to request a copy of all permits for the contractor's disposal facilities.

Q4. Do you foresee the requirement for a Hydrovac in case there are underground utilities in the excavation area?

A4. The scope of work has now been amended to remove the requirement to remove a 0.5m of soil beneath the stockpile locations. As a result, this question is no longer relevant.

Q5. Do you know if there are any underground utilities in the area where the contractor is to dig 0.5m below the stockpiles?

A5. The scope of work has now been amended to remove the requirement to remove a 0.5m of soil beneath the stockpile locations. As a result, this question is no longer relevant.

Q6. Given it is winter in the northern community of Lower Post and everything is frozen, is it reasonable to expect to get backfill material, which is indicated should be non-frozen? If so where would be a possible source?

A6. The scope of work has now been amended to remove the requirement to remove a 0.5m of soil beneath the stockpile locations. As a result, this question is no longer relevant.

Q7. We have attempted to contact the party responsible for the disposal/treatment facility but have not been successful. Can you provide the cost of disposal for the contaminated soil per tonne and the contact details?

A7. It is up to the bidder to consult with the appropriate supplier/vendor. PWGSC will not endorse a particular product or vendor.

Q8. We understand that the contaminated soil is stockpiled. Given that it is winter the soil under the contaminated pile is very likely frozen. Do you still envision having to excavate 0.5m of soil where the stockpiles are? This will require a hammer to break up the frozen dirt and we are of the opinion it will be costly.

A8. The scope of work has now been amended to remove the requirement to remove a 0.5m of soil beneath the stockpile locations. As a result, this question is no longer relevant.
