## Amendment 001

This amendment is raised to make the following changes to the tender document:

- 1) Tender closing date has changed to January 30, 2014, 2:00 PM Mountain Time
- 2) Construction can commence as soon as cross-country skiing has ended for the 2013/14 season (approximately April weather dependant). All in-stream works must be completed within the two Fisheries windows (May 1, 2014 to May 15, 2014 and August 15 to September 1, 2014). Construction must be completed by September 15, 2014. If contractor wishes to start mirco pile work prior to April, this will be allowed given that construction activities do not affect the cross-country ski offer.

All other terms, clauses and conditions remain unchanged.
