Amendment 002 is being raised to answer supplier questions from and after the site visit.

Will Environment Canada supply valves for the type 2 water?

We feel it is best that the tender supply the valves as they can match it to their piping.

Who steps down the water pressure? Qpods can't handle the new pressure.

Tender to supply and install pressure reducers prior to the polishing systems.

What is the water feed flow, pressure, temperature, etc (RO needs 5GPM us = 18.9L/min)?

Our current system (RIOS-100) satisfies our RO requirements. We are not asking the tender to provide an RO. We do not have the capability to measure these parameters in our current system.

What is the electrical capacity?

There are seven open spots on the electrical panel. The panel is rated for 100A.

There is a storage tank of 340L. Will we have to use it or just change it for a new one (350 +- 50L).

As per the requirement the storage tank in the ceiling needs to be removed and replaced with the 350L floor mounted storage tank.

Distribution system includes storage tank, piping, pump and UV. Will we have to change the old storage tank (170L), piping and pump?

The old storage tanks are to be removed and replaced by a new storage tank and water system, whatever that entails. This includes pipes and pump.

Is there any standard to respect for the UV sterilization?

It should be adequate to control biofilm.

What type of water is required for the lab?

We have type 2 water produced by the water system (also delivered to all marked points on bench tops).

Type 1 out of the polishing systems.

Is there any standard required by the government?

No.

Clarify the need of the lab: Flow, pressure, temperature, qty of treated water.

To clarify: We require the already stated requirements for flow (35L/min) and quantity (2000L/day), but we would expect pressure reducers to be installed prior to the polishing systems.

All other terms and conditions remain unchanged
