Questions and Answers

1) **Question:**

Part 6; subsection 6.1 Security requirements – Will CRA please confirm that all security requirements (Firm and Personnel) are a requirement for Contract Award and are not required at time of Bid Closing.

Answer:

There are no security requirements required at time of Bid Closing or Contract Award. The security requirements are for Personnel only and are required at time of Task Solicitation.

2) **Question:**

Will CRA confirm that named resources and resumes are not required at time of bid closing, but that all resources and their resumes will be evaluated for call ups once Task Solicitations have been sent to qualified suppliers.

Answer:

Confirmed, resumes are not required at time of bid closing. All resources and their resumes will be evaluated when Task Solicitations have been sent to qualified suppliers.

3) **Question:**

Will CRA please clarify how the different resource levels (i.e. junior, intermediate, and senior) will be weighted to account for the bid price in the scoring section in Part 4, Step 4?

Answer:

For the bid evaluation purposes all resource levels are treated equally.

4) **Question:**

Respectfully, we request that the above-noted solicitation is extended by three (3) weeks.

Answer:

The RFP has been extended by two (2) weeks. See amendments below.

5) **Question:**

Given that members of a joint venture can combine their experience to meet mandatory criteria **M 3.1, M 3.3 (but not M 3.2)**, we request that the Crown replaces "*The Bidder*" with "*The Bidder or its proposed sub-contractor*" for M 3.1, M3.3 and R1, R2, R3 and R4.

Answer:

No, CRA will not make the changes requested in Question 5.

6) **Question:**

Can the government, kindly, provide the historical value of any contract(s) resulting from Solicitation No.: 1000254119?

Answer:
