PART 1 - GENERAL INFORMATION

1. Security Requirement

There is no security requirement associated with this bid solicitation.

2. Requirement

3. Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days of receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

PART 2 - BIDDER INSTRUCTIONS

1. Standard Instructions, Clauses and Conditions

2. Submission of Bids

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

3. Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than ten (10) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be

clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the questions or may request that the Bidder do so, so that the proprietary nature of the question is eliminated, and the enquiry can be answered with copies to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

4. Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Alberta.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the bidders.

- (b) use a numbering system that corresponds to the bid solicitation.

To assist Canada in reaching its objectives, bidders should:

- 2.1** A bid must comply with the requirements of the bid solicitation and meet all mandatory technical evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.

Bidders must provide the required certifications and documentation to be awarded a contract.

The certifications provided by bidders to Canada are subject to verification by Canada at all times. Canada will declare a bid non-responsive, or will declare a contractor in default, if any certification made by the Bidder is found to be untrue whether during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply with this request will also render the bid non-responsive or will constitute a default under the Contract.

ANNEX A

REQUIREMENT

1. Requirement

Agriculture and Agri-Food Canada, Lacombe Research Centre, located in Lacombe, Alberta has a requirement for the supply, delivery and off-loading of one (1) new and unused 8-row, no tillage, Cross-Slot Plot Seeder as per the make, model and mandatory technical specifications detailed herein.

2. Mandatory Technical Specifications

2.1 General

- 2.1.1 Must be able to seed cereals, pulses, and oilseed crops into grass seed field residues (sod).
- 2.1.2 Must be capable of seeding forage grass and legume species into annual or perennial crop stubble.
- 2.1.3 Must be able to place all types of fertilizers (dry, liquid, gaseous, or dry+liquid) at time of seeding with minimum soil disturbance.
- 2.1.4 Must be capable of handling dense volumes of crop residue.
- 2.1.5 Must include carbide tipped openers specifically designed to cut through dense field residues produced by grass and legume seed production.
- 2.1.6 Must provide consistent seeding depth with automated electro-hydraulic control or equivalent.
- 2.1.7 Must include heavy-duty frame, hitch, openers, and hydraulic system.
- 2.1.8 Seeder should be supplied assembled, served and ready for operation.

2.2 Openers

- 2.2.1 Openers must have carbide tips or equivalent.
- 2.2.2 Openers with 2.5-3.5" ribbed press wheel tires, medium length standard blades, 22" notched coulter, dual powder coat finish or equivalent.
- 2.2.3 Must have only 8 rows on 30-cm-row spacings.
- 2.2.4 Each opener must be capable of creating a horizontal seed slot enabling placement of fertilizer at the same depth as seed however maintain fertilizer-seed separation necessary to prevent burning the seed.
- 2.2.5 Seeding depth must be adjustable for each opener.
- 2.2.6 Must have packing wheels to control seeding depth.
- 2.2.7 Each opener must be capable of banding dry, liquid, gaseous (or dry+liquid) fertilizers at seeding.

- 2.2.8 Openers must be capable of banding fertilizer into established grass seed stands with minimal disturbance (i.e., finished fertilizer must be placed in the soil (covered and packed) with minimal disturbance and ripping of sod).
- 2.2.9 Openers must be capable of banding fertilizer using same disc opener that sows seeds.

2.3 Hydraulic Control System

- 2.3.1 Must have an in-cab, electronic monitor for adjusting down pressure on openers and measuring hydraulic pressure.
- 2.3.2 Must have hydraulic memory valve system that instantly re-instates operating pressure after openers are lifted at headlands.
- 2.3.3 Includes twin bladder-type accumulators or similar model.
- 2.3.4 Openers must self-lift for transport.
- 2.3.5 Must have safety hydraulic lock-out valves.
- 2.3.6 Must include auto down force control system capable of applying a minimum of 1000 psi downforce.

2.4 Seed Delivery System

- 2.4.1 Must include air-assist delivery with hydraulic fan drive with fine roller assembly.
- 2.4.2 Must include a minimum 40 cubic ft. tank split for seed and fertilizer (stainless on one side of tank).
- 2.4.3 Must use flexible PVC hose for the seed delivery system.
- 2.4.4 Must include an installed agitator kit.
- 2.4.5 Must include a double gear box assembly with 60 speed or equivalent needed to apply a variety of rates of seed and/or fertilizer.
- 2.4.6 Must include a roller assembly with a minimum of a 12 gear course to control seed flow.
- 2.4.7 Must include a blocker kit, 8 outlets per side, installed to distribute seed and fertilizer to each of the 8 openers.
- 2.4.8 Must be easy and quick to calibrate seed and fertilizer.

2.5 Frame

- 2.5.1 Must include a heavy-duty frame capable of holding eight openers.
- 2.5.2 Frame must carry a minimum of 8000 lbs.
- 2.5.3 Openers must be mounted on two ranks.
- 2.5.4 Frame must be equipped with highway transport wheels.
- 2.5.5 Frame must include an adjusting hitch to change angle of openers.
- 2.5.6 Frame must include safety guard rails.

3. No Substitute Justification

Agriculture and Agri-Food Canada, Lacombe Research Centre conducts multiple research activities involving rotating field plots into and out of perennial grass and legume seed crops, which encompasses several herbaceous species all producing large amounts of field trash residues. These research activities emulate the commercial field situation wherein forage seed producers continuously cope with the

management of field trash residues and seek ways to improve rotating amongst perennial species or between perennial and annual crops.

The Cross-Slot Seeder is designed to seed into high levels of field crop residue to very shallow depths but not push residue into the seed row which reduces forage and annual crop establishment because the small seeds must be in direct contact with the soil. Seed slots created by the openers are horizontal. All other types of openers create seed slots which are vertical. The Cross Slot Seeder also provides consistent seeding depth using automated electronic-hydraulic control system for pressure on the openers that is not available on any other type of drill. The design of these openers ensures excellent stand establishment of forages and annual crops into any type of crop stubble while retaining 70-90% of crop residue at the soil surface. This is part of the work plan requirement for a collaborative project with Peace Region Forage Seed Association.
