Question 1: What are the dimensions of the vertical cable management and are door(s) required?

- Vertical CMS Front and Rear
 - Because CBSA requires Vertical CMS on all four corners, please provide whatever is recommended for the cabinet. It must be able to accommodate the equipment being proposed. The cabinets can have either enclosed CMS or lancing bars.
- Modify the shelves required - 1 x 3U, 5 X 2U and 1 x 1U
- Doors
 - We require the rack to have a standard back door and a Front Plexi Door with Lock

Question 2: What is the power requirement for the Power Bar, it states 20-AMP, it is assumed that is the input side but we need to know what the output side is and how many and type(s) for the receptacles as well

- 12 outlets (15 amp)
- The power bar needs to accommodate the servers and switches, therefore the power bar must be compatible with what is proposed for hardware.
- The power bar will plug into the back of the UPS, therefore the power requirement for the power bar must match the amperage requirement on the back of the UPS (therefore it may not have to be 20-amp)

If the answers affect your bid, you must forward an updated copy of your offer to the Bid Receiving Unit by closing date and time indicated on the front of the solicitation document.
