PART 1 - GENERAL INFORMATION

1. Security Requirement

There is no security requirement associated with this bid solicitation.

2. Requirement

The requirement is detailed under Article 2 of the resulting contract clauses.

3. Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days of receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

PART 2 - BIDDER INSTRUCTIONS

1. Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the Standard Acquisition Clauses and Conditions Manual

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

2. Submission of Bids

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

3. Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than fifteen (15) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the questions or may request that the Bidder do so, so that the proprietary nature of the question is eliminated, and the enquiry can be answered with copies to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

4. Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Saskatchewan.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the bidders.

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that bidders follow the format instructions described below in the preparation of their bid:

- (b) use a numbering system that corresponds to the bid solicitation.

- 2) use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders.

Section I: Technical Bid

In their technical bid, bidders should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work.

Section II: Financial Bid

2. Basis of Selection

2.1 Basis of Selection - Mandatory Technical Criteria

A bid must comply with the requirements of the bid solicitation and meet all mandatory technical evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract.

PART 5 - CERTIFICATIONS

Bidders must provide the required certifications and documentation to be awarded a contract.

The certifications provided by bidders to Canada are subject to verification by Canada at all times. Canada will declare a bid non-responsive, or will declare a contractor in default, if any certification made by the Bidder is found to be untrue whether during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply with this request will also render the bid non-responsive or will constitute a default under the Contract.

Portable Ultrasound Scanning System in accordance with the following specifications:

a) Portable Ultrasound Scanning System must be compact and lightweight and able to be carried by hand between exams.

b) Must be capable of providing two-dimensional (2-D) images of soft tissue and moving structures for a variety of general-purpose applications including foreign body detection, intrauterine pregnancy assessment and abdominal sonography in trauma.

c) The system must weigh 12 kg or less

d) The system must be one piece

e) Scan Modes: Must present the scan in the following modes: B-mode (2D), M-mode

f) Doppler Types: Must have the following features:

i) Color Doppler velocity

ii) Pulsed Wave (PW): Duplex (2D plus PW Doppler) and Triplex (2D plus PW Doppler + Doppler Color)

iii) Color-Flow Mapping (CFM)

iv) Spectral Doppler Imaging

g) Probes: (MHz and Types) The Ultrasound device must possess multi-frequency probes to cover the following applications: regional anaesthesia, vascular, cardiology, abdominal, musculoskeletal and gynaecological. The device must be provided with at least three probes; one of each: linear, curved and phased array

h) Cine Loop Playback:

Must playback on time previously scanned.

i) Scan Converter:

Greyscale levels: Must be 256 minimum

j) Software Features: Must have the following features:

i) Digital capilers

ii) Vascular analysis

iii) Obstetric analysis

k) Image Processing: Must have the following features:

i) Zoom capability, freeze, reverse, right, left and rotation.

ii) Tissue Harmonic Imaging (THI) sonography

l) Image Storage: Must have the following features:

i) Configurable DICOM (Digital Imaging and Communications in Medicine).

ii) Must have Raw Data storage and configurable compression feature.

iii) Must browse images and have an image manager feature

iv) Must have USB support for external CD/DVD-RW storage

m) Monitor:

i) Must be a minimum of 12 inches and a maximum of 19 inches on the diagonal.

ii) Must have a touch screen

n) Outputs: Must have the following features:

i) SVGA, Earphones, Ethernet and microphone.

o) Power Requirements:

i) Must be 120 VAC, 60 Hz

ii) Must have Ethernet or wireless image/data transfer.

p) Others:

i) The Ultrasound Scanner must have a Health Canada medical device license. Supporting documentation must be provided

ii) The system must be provided with a cart that holds the portable device with all the probes.
