**Question 1:**

Square footage of the facility.

**Answer:**

The building is approximately 4740 m<sup>2</sup> in size, of which 3606 m<sup>2</sup> is to be cleaned under this contract.

**Question 2:**

Square footage of finished floor.

**Answer:**

3606 m<sup>2</sup> consists of various floor types all of which are included in this contract. Flooring types are carpet, lino, tile, concrete and epoxy, (196.4 m<sup>2</sup> is cell block epoxy), there will be no further breakdown provided for the other floor types.

**Question 3:**

Square footage of carpeted floor.

**Answer:**

2764.8 m<sup>2</sup> is the approximate amount of carpeted flooring in the building.

**Question 4:**

Table 2 in Annex D – Is this strictly for excluded work, separate from regular contracted work.

**Answer:**

Yes, this is for an Hourly Rate for services on a required basis outside the contract scope of work.
