This amendment is raised to address the following questions:

Annex A – Pg. 12 Question 1: #5 "Serge Flag Label: - Explain "Flag" Label?

Answer 1: Flag Label is the main label.

Question 2: #12 Topper (Blue/Firm) Foam. Usually "Blue" refers to blue memory foam which is a softer foam or should this be regular flexible polyurethane foam?

Answer 2: Topper is to be 2" firm foam.

Question 3: #8 Never Turn Panel-Are these no Flip Mattresses? What is the reference to "183m/roll"? There is reference to "smooth top" but in #6 the panel to be quilted. Explain.

Answer 3: Yes, the mattresses are to be no flip mattresses. Remove any reference to 183m/roll. The mattress is to have a quilted top panel and a smooth bottom panel.

Question 4: #13 Panel/Inner Labor-Explain what you are looking for?

Answer 4: Labor should read Layers.

Question 5: #10 Spring/Core-reference to multi-lastic spring. Does this refer to a continuous Coil unit?

Answer 5: Yes, Mattress must be a continuous coil unit.

Question 6: #25 Set of Legs-Are you looking for a plastic screw to the base style leg? The alternative is a screw in wood leg.

Answer 6: The actual legs can be plastic or wooden with heavy duty plastic rigid glides that must screw into the box spring and must be 7" high.

Question 7: #22 Posture Base-For the wood foundation, do you want cardboard or wood mende board on the top?

Answer 7: Posture base must be wood not cardboard.

Question 8: Page 11 Deliver & Unloading-Is only unloading required from the transport or are the sets to be installed in different rooms?
