PART 1 - GENERAL INFORMATION

1. Introduction

The Request for Standing Offers (RFSO) is divided into seven parts plus attachments and annexes, as follows:

2. Summary

2.1 Requirements

To supply Packaged Oil and Lubricants to the department of National Defense across Canada as detailed at Annexes A and B attached hereto; as and when requested by the Identified User, during the period of March 1, 2014 up to and including February 29, 2016. The required items are classified into two groups:

2.1.1 Requirement for Army and Air Forces

The items detailed in Annex A are products intended to be used for Army and Air Forces needs. The items are to be supplied on a regional basis. The regions are as follows:

- The **Atlantic** region that includes the provinces of Nova Scotia, PEI, New Brunswick and New Found Land & Labrador;
- The **Quebec** region;
- The **Ontario** region ;
- The **Western** region that comprises Manitoba, Alberta, Saskatchewan and BC; and
- The **Northern** region which includes all the locations in Yukon and Northwest Territories.

More than one Standing Offer will be issued as a result of this Solicitation on an item by item basis per region.

2.1.2 Requirement for Navy

The required lubricant items for Navy are detailed in Annex B. The items will be supplied on a regional basis but each item will be issued to only one supplier per region. The regions are as follows:

- **East Coast Region** for delivery to Halifax, NS.
- **West Coast Region** for delivery to Esquimalt, BC

More than one Standing Offer may be issued as a result of this Solicitation on an item by item basis.

NOTE:

The navy requirement is subject to the same terms and conditions in this solicitation but the Standing Offers for navy requirement will be awarded on a different requisition No W8486-149350.

2.2 Code of Conduct and Certifications

Pursuant to section 01 of Standard Instructions 2006 and 2007, offerors must submit a complete list of names of all individuals who are currently directors of the offeror. Furthermore, as determined by the Special Investigations Directorate, Departmental Oversight Branch, each individual named on the list may be requested to complete a Consent to a Criminal Record Verification form and related documentation.

2.3 Trade Agreements

This requirement is subject to the provisions of the World Trade Organization Agreement on Government Procurement (WTO-AGP), the North American Free Trade Agreement (NAFTA), the Canada-Chile Free Trade Agreement (CCFTA), the Canada-Peru Free Trade Agreement (CPFTA), the Canada-Colombia Free Trade Agreement and the Agreement on Internal Trade (AIT).

2.4 Comprehensive Land Claims Agreements

This NISO allows for deliveries all across Canada including Land Claim Settlement areas.

The following Comprehensive Land Claims Agreements will apply to any resulting call-ups:

- For deliveries to * Inuvik, NT, the Inuvialuit Final Agreement and the Gwich'in Comprehensive Land Claim Agreement.
- For deliveries to* Yellowknife, NT, the Tlicho Agreement

the Kwanlin Dun First Nation Final Agreement; and

* where "deliveries to" means "goods delivered to, and services performed in".

3. Debriefings

Offerors may request a debriefing on the results of the request for standing offers process. Offerors should make the request to the Standing Offer Authority within 15 working days of receipt of the results of the request for standing offers process. The debriefing may be in writing, by telephone or in person.

PART 2 - OFFEROR INSTRUCTIONS

1. Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the Request for Standing Offers (RFSO) by number, date and title are set out in *Standard Acquisition Clauses and Conditions Manual* (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Offerors who submit an offer agree to be bound by the instructions, clauses and conditions of the RFSO and accept the clauses and conditions of the Standing Offer and resulting contract(s).

The 2006 (2013-06-01) Standard Instructions - Request for Standing Offers - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the RFSO.

Subsection 5.4 of 2006, Standard Instructions - Request for Standing Offers - Goods or Services - Competitive Requirements, is amended as follows:

Delete: sixty (60) days

Insert: one hundred twenty (120) days.

2. Submission of Offers

Offers must be submitted only to Bid Receiving Unit, Public Works and Government Services Canada (PWGSC) by the date, time and place indicated on page 1 of the Request for Standing Offers.

3. Improvement of Requirement During Solicitation Period

Should offerors consider that the specifications or Requirement contained in the RFSO could be improved technically or technologically, offerors are invited to make suggestions, in writing, to the Standing Offer Authority named in the RFSO. Offerors must clearly outline the suggested improvement as well as the reason for the suggestion. Suggestions that do not restrict the level of competition nor favour a particular offeror will be given consideration provided they are submitted to the Standing Offer Authority at least twenty (20) days before the RFSO closing date. Canada will have the right to accept or reject any or all suggestions.

4. Enquiries - Request for Standing Offers

All enquiries must be submitted in writing to the Standing Offer Authority no later than ten (10) calendar days before the Request for Standing Offers (RFSO) closing date. Enquiries received after that time may not be answered.

Offerors should reference as accurately as possible the numbered item of the RFSO to which the enquiry relates. Care should be taken by offerors to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the questions or may request that offerors do so, so that the proprietary nature of the question is eliminated, and the enquiry can be answered with copies to all offerors. Enquiries not submitted in a form that can be distributed to all offerors may not be answered by Canada.

5. Applicable Laws

The Standing Offer and any contract resulting from the Standing Offer must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

Offerors may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their offer, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the offerors.

PART 3 - OFFER PREPARATION INSTRUCTIONS

1. Offer Preparation Instructions

Canada requests that offerors provide their offer in separately bound sections as follows:

Section I: Technical Offer (two (2) hard copies)

Section II: Financial Offer (one (1) hard copy)

Section III: Certifications (one (1) hard copy)

Prices must appear in the financial offer only. No prices must be indicated in any other section of the offer.

Canada requests that offerors follow the format instructions described below in the preparation of their offer.

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to that of the Request for Standing Offers.

In April 2006, Canada issued a policy directing federal departments and agencies to take the necessary steps to incorporate environmental considerations into the procurement process Policy on Green Procurement

(<http://www.tpsgc-pwgsc.gc.ca/ecologisation-greening/achats-procurement/politique-policy-eng.html>).

To assist Canada in reaching its objectives, offerors should:

- 1) use 8.5 x 11 inch (216 mm x 279 mm) paper containing fibre certified as originating from a sustainably-managed forest and containing minimum 30% recycled content; and
- 2) use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders.

Section I: TECHNICAL OFFER

In their technical offer, offerors should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work. The offeror must consider the following elements in its technical offer.

Mandatory information to include in the offer:

1. Product Information

Brand name, and where applicable, the reference number of products offered are to be stated on Annex A or B of the offer. The Offeror must include all required reference numbers, letters, Certificates of Analysis (CoA), and Material Safety Data Sheets (MSDS) pertaining to each product specified in Annex A and B with its offer. Offerors should provide the required technical information with their offer or promptly thereafter. If the required technical information has not been received by the time the evaluation of offers is completed, the Standing Offer Authority will request it in writing from the offeror. Failure to provide the technical information within the requested time frame will render the offer non-responsive.

The following information is required:

1.1 Where a Qualified Products List (QPL) is specified for the item at Annex A or B:

a. Qualification reference number must be stated in the offer if product offered is listed on the published QPL, otherwise a letter from the appropriate qualifying authority for the applicable specification is required with the offer, and

b. Product offered must be qualified by the appropriate qualifying authority for the applicable specification at the time of solicitation closing date, or

1.2 Where a Performance Review Institute (PRI), American Petroleum Institute (API), or Allison listing is specified for the item at Annex A and B:

a. Appropriate reference number (qualification number, approval number, license number) must be stated with the offer if product is listed on the published list/directory, otherwise a letter from the appropriate authority for the applicable specification is required with the offer, and

b. Product offered must be qualified/approved/licensed by the appropriate authority for the applicable specification at the time of solicitation closing date.

1.3 Where test are specified for the item at Annex A and B:

a. A CoA from a recognized laboratory is required with the offer, and

b. The CoA results must demonstrate qualification to all requirements of the applicable specifications, and

c. The CoA must indicate the requirement/property, test method used, and results obtained with units, and

d. The CoA must be signed, dated, and must indicate the date of manufacture and batch number of product tested, and

e. The product tested must be of the same batch as the product offered initially, and

f. The CoA must not be expired. A CoA is considered to have expired when the product (batch) reaches the date of first re-test (according to the minimum re-test frequency set out for each item and referred to as "Re-test (months)" at Annex "A") after the date of manufacture.

1.4 Where a Technically Approved Products List (TAPL) is specified for the item at Annex B:

a. offerors are required to provide a TAPL letter showing that this product is approved to the current issue of the applicable Department of National Defence Specification. Only products with this approval will be considered.

b. Product offered must be qualified by the appropriate qualifying authority for the applicable specification at the time of solicitation closing date.

2. Material Safety Data Sheet (MSDS)

The MSDS is required with the offer for assessment purposes; it must disclose the chemical ingredient information along with its Chemical Abstract Service (CAS) number, percent composition (the offeror may provide confidential information in a separate document), and Volatile Organic Compound (VOC) content where applicable.

Note: Proprietary information will be treated with confidentiality.

3. Substances Concentration Limits

- a. The product offered must comply with ingredients concentration limits set by "*Canadian Environment Protection Act*" (CEPA) regulations, including the proposed "*Volatile Organic Compound (VOC) Concentration Limits for Certain Products Regulations*".

4.1 Multiple products offered

Offerors may offer multiple alternate products for the same item number with one price applicable for all products offered under that item. All products offered will be evaluated against the same criteria. If all products offered are technically compliant, the offeror will be allowed to supply any of the qualified product under that item number. The products qualified under a same item number must have been assigned the same number of points according to the point rated criteria in order for a supplier to be allowed to supply any of the qualified products under the same item number.

If any of the products offered is not technically compliant, It will be removed from the offeror's list and only the remaining technically compliant products will be considered for further evaluation.

After the Standing Offer is in place, the product(s) supplied must be the product(s) listed in the Standing Offer only and supplier(s) cannot supply a substitute product(s).

5. Repackaging

Requirements for repackaged lubricants:

The Offeror is required to declare for each item whether he is the original manufacturer. Where an offeror is not the original manufacturer of the lubricant, the offeror must state whether the lubricant will be repackaged by any party other than the original manufacturer. In order for repackaged items to be acceptable, it is mandatory for the offerors to:

- a) Demonstrate, in their offer or prior to the issuance of the Standing Offer, accreditation of the repackaging organization (RPO) to a recognized quality scheme such as ISO 9000 or its derivatives, or comply with the requirements of AQAP 2120;
- b) Submit, with their offer or prior to the issuance of the Standing Offer, a copy of their quality management plan for the repackaging of each item to be repackaged or a Certification of accreditation as listed in paragraph a) above.

The quality management plan must include as a minimum:

- location where the repackaging is to take place;
 - how the process is to be achieved;
 - details of how contamination from previous products will be avoided;
 - how the RPO will maintain batch control, given that mixing of different batches is not permitted;

- how the RPO will demonstrate that no degradation of product quality has occurred.

Section II: Financial Offer

Offerors must submit their financial offer in accordance with "Annex C, Basis of Payment". The total amount of Applicable Taxes must be shown separately.

1. Unit Price

The firm unit price must be in Canadian dollars DDP destination Incoterms 2000 and must not exceed 2 decimals.

Offerors must submit a unit price per unit of issue for the item in Annexes A or B within a zone (geographical area) they wish to compete for.

2. Exchange Rate Fluctuation

The requirement does not offer exchange rate fluctuation risk mitigation. Requests for exchange rate fluctuation risk mitigation will not be considered. All offers including such provision will render the offer non-responsive.

3. Payment by Credit Card

Canada requests that offerors complete one of the following options:

Section III : CERTIFICATIONS

Offerors must submit the certifications required under Part 5.

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

1. Evaluation Procedures

(a) Offers will be assessed in accordance with the entire requirement of the Request for Standing Offers including the technical and financial evaluation criteria.

(b) An evaluation team composed of representatives of Canada will evaluate the offers.

1.1 Technical Evaluation

Offers must contain all the technical information requested in the Request for Standing Offer to enable a full and complete evaluation.

1.1.1 Mandatory technical criteria

The goods offered must conform to all aspects of the specifications and standards detailed herein:

- a) Technical compliance in accordance with Annexes A and B;
- b) Submission of the all the mandatory information requested as part of the Technical offer.

Offers not meeting these mandatory technical criteria will be declared non-responsive.

1.1.2 Point Rated Technical Criteria

The rating is performed on a scale of ten (10) points. The rating of a product offered will be based on the assessment of ingredients contained in the proposed product and will be determined by the points assigned as follows:

- 10 points for a product that is not a controlled product;
- 5 points for a controlled product containing substances of category A, B, or C;
- 2 points for a controlled product containing substances of category D;
- 0 point for a controlled product containing substances of category E

Note 1: Based on the product's MSDS chemical ingredients information (CAS number), the chemical ingredients contained in the product will be identified by verifying the CAS number of the chemical against lists of controlled products.

Note 2: Controlled product is defined herein as product containing substances of any of the following categories:

- Category A: targeted chemical(s) subject to the National Pollutant Release Inventory (NPRI);
- Category B: substance(s) targeted by the Chemicals Management Plan;
- Category C: substance(s) listed under the Accelerated Reduction/Elimination of Toxic (ARET) Substances Program; or
- Category D: substances added in Schedule I, Toxic Substance list under the CEPA (Canadian Environment Protection Act).
- Category E: Substance(s) regulated under Canadian Environment Protection Act (CEPA).

1.1.3 Environment, Health and Safety assessment

No controlled products will be accepted if another product, technically compliant and higher rated, is available.

1.2 Financial Evaluation

The following Mandatory factors will be taken into consideration in the evaluation of each offer:

Compliance with the Basis of Payment as per Annex "C".

2. Basis of Selection

The Standing offers will be issued on a regional basis. The offeror will have the choice to submit their offer for any item for one or more regions. Neither the offer that receives the highest number of points nor the lowest price will necessarily be accepted.

1. To be declared responsive, an offer must:

- a) comply with all the requirements of the Request for Standing Offers; and
- b) meet all mandatory technical and financial evaluation criteria.

2. Offers not meeting (a) or (b) will be declared non-responsive.

The responsive offer with the highest number of points in a region, on an item by item basis, will be recommended for issuance of the Standing Offer in that region. In case of a tie between two or more offers with equal number of points, the offer with the lowest unit price evaluated, will be recommended for issuance of the Standing Offer.

More than one Standing Offer will be issued as a result of this solicitation but only one offer per item and per region will be selected.

PART 5 - CERTIFICATIONS

Offerors must provide the required certifications and documentation to be issued a standing offer.

The certifications provided by offerors to Canada are subject to verification by Canada at all times. Canada will declare an offer non-responsive, will have the right to set-aside a standing offer, or will declare a contractor in default, if any certification is found to be untrue whether during the offer evaluation period, during the Standing Offer period, or during the contract period.

The Standing Offer Authority will have the right to ask for additional information to verify the Offeror's certifications. Failure to comply with this request will also render the Offer non-responsive or may result in the setting aside of the Standing Offer or will constitute a default under the Contract.

1. Mandatory Certifications Required Precedent to Issuance of a Standing Offer

1.1 Code of Conduct and Certifications - Related documentation

By submitting an offer, the offeror certifies that the offeror and its affiliates are in compliance with the provisions as stated in Section 01 Code of Conduct and Certifications - Offer of Standard Instructions 2006. The related documentation therein required will assist Canada in confirming that the certifications are true.

1.2 Federal Contractors Program for Employment Equity - Standing Offer Certification
