The purpose of this amendment is to add ADDENDUM NO. 2, attached separately; to add an additional Site Visit, and answer a question, as follows:

**ADDITIONAL SITE VISIT:**

It is recommended that the Bidder or a representative of the Bidder visit the work site. Arrangements have been made for a tour of the work site. The site visit will be held on, 10 January 2014 at 10:00 a.m. meeting at Fort Dufferin Reception, accessible through the Dewdney Avenue Entrance, Bonner Drive. Bidders may be requested to sign an attendance form. Bidders who do not attend or send a representative will not be given an alternative appointment, but they will not be precluded from submitting a bid. Any clarifications or changes to the bid solicitation, resulting from the site visit, will be included as an amendment to the bid solicitation.

**QUESTION AND ANSWER:**

- Q1.** During the site visit on December 23<sup>rd</sup> it was stated that no vehicles are allowed on the parade square side of the building (East). Please specify equipment access route and boundary on this side of the building we would be restricted to? There is no reference to this within the contract documents, unless clarified by addendum. We are presuming full access to the East side of the B block building (Parade Square) with no restrictions.
- A1.** *Access to the east side, including the parade square, will be allowed but must be coordinated with the RCMP Project Manager.*
