PART 1 - GENERAL INFORMATION**1. Security Requirement**

There is no security requirement associated with this bid solicitation.

2. Requirement

The requirement is detailed under Article 2 of the resulting contract clauses.

3. Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days of receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

PART 2 - BIDDER INSTRUCTIONS

1. Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the *Standard Acquisition Clauses and Conditions Manual* (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The 2003 (2013-06-01) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

2. Submission of Bids

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

3. Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than seven (7) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the questions or may request that the Bidder do so, so that the proprietary nature of the question is eliminated, and the enquiry can be answered with copies to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

4. Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Alberta.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the bidders.

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

- (b) use a numbering system that corresponds to the bid solicitation.

- 1) use 8.5 x 11 inch (216 mm x 279 mm) paper containing fibre certified as originating from a sustainably-managed forest and containing minimum 30% recycled content; and
- 2) use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders.

In their technical bid, bidders should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work.

2. Basis of Selection

A bid must comply with the requirements of the bid solicitation and meet all mandatory technical evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated price per item will be recommended for award of a contract for that item.

A maximum of 2 contracts may be awarded, one for each item. If one bidder is recommended to be awarded for both items, one contract may be awarded.

PART 5 - CERTIFICATIONS

Bidders must provide the required certifications and documentation to be awarded a contract.

The certifications provided by bidders to Canada are subject to verification by Canada at all times. Canada will declare a bid non-responsive, or will declare a contractor in default, if any certification made by the Bidder is found to be untrue whether during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply with this request will also render the bid non-responsive or will constitute a default under the Contract.

REQUIREMENT

Aerospace Engineering Test Establishment (AETE) at the Department of National Defence, 4 Wing Cold Lake requires the supply of specialized equipment to be delivered to their location in Cold Lake, Alberta.

AETE requires two items: (may be bid upon separately)

1. An Adjustable Table
2. A Clean Bench with Ventilation Unit

Background

Aerospace Engineering Test Establishment (AETE) require specialized equipments in order to improve the capability to:

- prepare for and conduct Aviation Life Support Equipment and Escape Systems testing.
- fulfill accident investigation responsibilities at the request of the Directorate of Flight Safety.

The Crew Systems section is responsible for providing AETE with test and evaluation expertise on aviation life support equipment and escape systems for all aircraft fleets.

Minimum Performance Specifications

Instruction to Bidders:

- Bidders must address each Minimum Performance Specification listed below, whether the product offered "Meets" or "Does not Meet" and should provide supporting documentation for each item. The Crew Systems requires a table to develop and implement modifications to life support equipment and escape systems, assemble test articles, and fit personnel with equipment. This table will be the main work surface and will be required for tasks such as cutting webbing using a hot knife.

- The adjusting can be done by crank, hydraulic, or electric, just so long as the adjustment can be done by one person while there is a load on the table.
