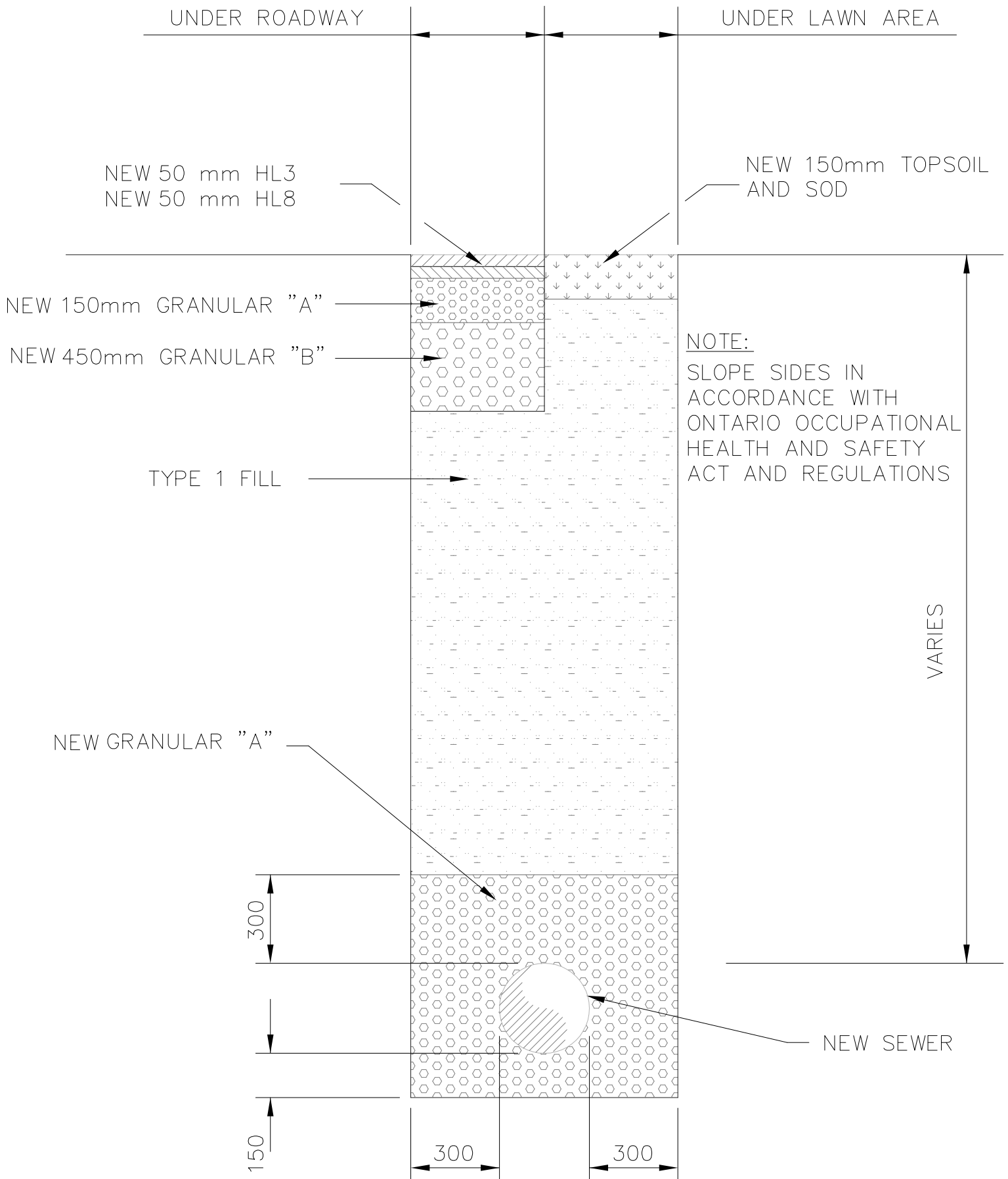
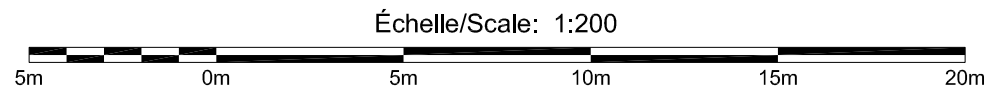


- NOTES:

 2. DO NOT ENCUMBER SITE OUTSIDE STAGING/STORAGE AND HOARDING AREAS INDICATED.
 3. AT ALL TIMES MAINTAIN ACCESS TO LOADING DOCK AND TWO WAY VEHICLE ACCESS THROUGH SITE.
 4. REMOVE STAGING/STORAGE COMPOUND AND HOARDING AREA UPON COMPLETION OF STORM SEWER INSTALLATION. MAKE GOOD SURFACES TO EQUAL OR BETTER CONDITION THAN PREVIOUS EXISTED.
 5. REINSTATE SURFACES AS INDICATED
 6. PROTECT ALL TREES WITHIN WORKING ZONES AND VICINITY
