**Questions (Q) and Answers (A)**

Q1. Annex 'A', 5.1.6

Given the number of fabric panels that abut other on a sofa it is impossible to have patterns align at all seams. Please confirm that this is not a requirement.

A1. *There are no sofas. Chairs only. There will not be a requirement to match pattern. The fabric will be solid colour or abstract pattern.*

Q2. Annex 'A', 6.7

The requirement states the lounge chair is to have 'a universal, left or right hand tablet arm that must be adjustable or rotate'. Does this mean that the tablet can be located on either the left side or right side of the lounge chair by the user of the chair or just that the tablet is the same which ever side of the lounge chair it is mounted on?

A2. *There is a requirement for some left hand tablettes and some right hand tablettes (to accommodate left hand and right hand people). The quantity of each to be confirmed.*

Q3. In regards to Solicitation 45045-130088/A for Single Seat Lounge Chair w/ Tablet I have 2 question.

Can the Technical Bid and Financial Bid be submitted on an USB stick instead of a CD or DVD?

A3. No, USB sticks / USB keys / USB flash drives are not acceptable.

Q4. Is delivery to one floor or multiple floors?

A4. *Statistics Canada here in Tunney's occupies 3 buildings: R.H. Coats Building, Main Building and Jean Talon Building. All buildings are connected via the basement area (as well as the ground floor). The Main Building is located between the R.H. Coats and the Jean Talon. Furniture for the R.H. Coats (3 floors) will be delivered to the Main Building loading dock. Furniture for the Jean Talon (1 floor) will be delivered to the Jean Talon loading dock as well as furniture going into storage in the basement of the Jean Talon Building.*
