3. Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than five (5) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the questions or may request that the Bidder do so, so that the proprietary nature of the question is eliminated, and the enquiry can be answered with copies to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

4. Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in province of Quebec.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the bidders.

Canada requests that bidders follow the format instructions described below in the preparation of their bid:

- (b) use a numbering system that corresponds to the bid solicitation.

In April 2006, Canada issued a policy directing federal departments and agencies to take the necessary steps to incorporate environmental considerations into the procurement process Policy on Green Procurement (<http://www.tpsgc-pwgsc.gc.ca/ecologisation-greening/achats-procurement/politique-policy-eng.html>). To assist Canada in reaching its objectives, bidders should:

- 1) use 8.5 x 11 inch (216 mm x 279 mm) paper containing fibre certified as originating from a sustainably-managed forest and containing minimum 30% recycled content; and
- 2) use an environmentally-preferable format including black and white printing instead of colour printing, printing double sided/duplex, using staples or clips instead of cerlox, duotangs or binders.

ANNEX «A»

→ REQUIRED SPECIFICATIONS:

Firing valve

The firing valve quick opening must be actuated by an air pressure and be adaptable to a complex ballistic system launching projectiles at high velocities composed of multiple guns using helium gas as the propellant. The facilities are now functional and efficient with an aging firing valve that need to must be replaced. For operational purposes, we cannot accept that the new valve requires changes in existing configurations of the set-up. The entry and exit of the propellant helium gas is mounted on pipe Swagelock 0.5 inch outside diameter (O.D.). The overall dimensions of the valve must not exceed 8 inches in height by 8 inches long and 6 inches wide.

The quick opening valve normally closed - NC Ball Valve should have a switching time from close to open of 0.0026 seconds or less, an internal air pressure of 4500 psig and an activation pressure of 1500 psig. The valve must be able to operate with an air pressure activation of 800 to 3000 psig. This valve should be controlled by a solenoid activated on the 24 VDC. The use of a helium pressure of 6000 psig as the propellant should not interfere with the functioning of the valve.
