Q1: Does the dredging operation have to be land base as per item 1.1 of section 01-11-00 of specifications? "Work under this contract consists of ... land based dredging of the harbour, transport material to the containment cell at Escuminac ..."

A1: Yes

Q2: What is the time window for the dredging operations (date of start and date of completion for the dredging operations)? The only time frame I saw was that the work was to be completed 6 weeks after contract award.
