AMENDMENT 005

This amendment is issued in response to the following questions.

1. Annex B, Basis of Payment, Section "Delivery and Installation Notes"

Question:

Requires initial delivery of Phase 3 to 1045 Main Street with installation to take place at a later date at 95 Foundry Street. Is the installing dealer required to get Phase 3 furniture to the 6th Floor of the 1045 Main Street location as stated or will it be stored in a ground floor warehouse until it is moved to 95 Foundry Street?

Answer:

The Phase III furniture will be stored in the sub basement of 1045 Main Street until it is sent to 95 Foundry Street for final installation. This sub basement is accessible via a loading dock and a freight elevator. It will accept skids.

2. Annex B, Basis of Payment, Section "Delivery and Installation Notes"

Question:

Requires initial delivery of Phase 3 to 1045 Main Street with installation to take place at a later date at 95 Foundry Street. Is the installing dealer responsible for transporting the furniture from storage at 1045 Main Street to the installation site at 95 Foundry Street?

Answer:

The installing dealer is required to transport the Phase III furniture from 1045 Main Street to 95 Foundry Street for final installation.

3. Annex B, Basis of Payment, Products 15 and 16

Question:

Should it be assumed that the keyboard cut out will be the opposite handing to the crank handle in both cases?

Answer:

Yes

4. Annex A, Requirement, Section 6.1.3

Question:

It states "Tables 7 to 16 to be crank height adjustment tables with the crank on front (under surface) of table and a minimum height range of 648mm (25.5") to 1066mm (41"). Is it the keyboard or the table that must go as low as 25.5"? If the table, then are you requiring the keyboard to go a further 7" lower to 18.5"H? The current Freestanding Supply Arrangement contract E60PQ-090004 has a sit-to-stand requirement of only 27" to 41".

Answer:

The table must go as low as 25.5". Table range of 27" to 41" would be acceptable.

5. Annex A, Requirement, Section 6.1.5

Question:

It states "Tables 7 to 16 to have cut out keyboard trays. Keyboard tray to be 686mm (27") long x 279mm +/- (11" +/-) deep. What is the +/- tolerance on the depth of the keyboard.

Answer:

Tolerance to be 25.4mm (1")

Question 6:

Can each phase be invoiced separately once product has been delivered?

Answer 6:

Yes, except Phase 3. Product and freight can be invoiced at time of delivery and installation can be invoiced once completed.

7. Annex A, Requirement - Section 6.1.5

Question:

It states "All tables above 1525mm (60") to have keyboard tray mounted 254mm (10") from side edge of table." The drawing marked SK-2 however, indicates that this spacing is to be 267mm. Please indicate which is correct.

Answer:

Correct dimension is 254mm (10") from edge.

8. Article 6.6.2 Personal Storage Towers

Question:

Allowable height is shown at 51" max - would 54" height be acceptable?

Answer:

No. 54" is not acceptable as it exceeds the height of the panels that have been ordered for this project.

9. Annex A 6.2.4

Question:

Would item be acceptable if the open cabinet and adjustable shelf space was located on the side as opposed to the front as indicated in the sketch (SK-3)? Opening would of course alternate with left and right wardrobe selection.

Answer:

No

10. Annex "B" - Basis of Payment - Product #5

Question:

Phases for Tables II and III do not match Table I for lines two and three of Product #5.

Answer:

The tables are correct. There are different delivery and installation dates.

All other terms and conditions remain unchanged.
