Please confirm if electrical is available also at 120V, single phase, 9.5 amps.

**Question:****2. Position vs right wall and possibility to relocate**

The position of the unit vs the right hand wall seems a problem as it does not meet:

-minimum service requirements of 12 inch from the wall;

And

-latest 2008 revision of Nova-Scotia pressure vessel code, asking for minimum 16 inch clearance.

In addition, the picture shows a small white water heater, disconnect switch, and a bench mounted apparatus on the left hand side, limiting the possibility to move left.

The supplier can connect to services, but the space has to be sufficient to meet regulatory and allow for installation in agreement with NS codes.

Please confirm that approximately 60 inch width (30" for the unit, plus 16" on right & left side) will be made available for this installation.
