**AMENDMENT 004 ANSWERS QUESTIONS FROM A POTENTIAL BIDDER**

- Q1.** We require clarification on the security requirements for the mobiles systems. What is the difference between "Protected B" and "Confidential" and what security features are needed with the mobile systems to satisfy the different security levels?
- A1.** From a technical standpoint - nothing. These are logistical divides of our collection that differentiate materials beign held of differeing corporate security classification.
- Each mobile system must lock down separately with its own unique key as per Annex A.
- Q2.** Please clarify amendment #2. It mentions six guide wheels per rail and it mentions a minimum of six wheels per movable carriage. These are two different statements.
- A2.** It is required that 3 sets of wheels = 6 total on a carriage be used to improve weight distribution across the unit.
- Q3.** We request an extension of one week
- A3.** The closing date remains unchanged
