Calculation of Financial Score: the financial score is calculated by giving full points (20) to the lowest priced responsive proposal (based on the proposal's **Total Estimated Cost**) and prorating all other responsive proposal financial scores accordingly.

The calculation used to determine points for all other Bidders (other than the lowest) will be Lowest **Total Estimated Cost** (\$) divided by Bidder's **Total Estimated Cost** (\$), multiplied by 40 points, as follows:
