PART 1 - GENERAL INFORMATION

1. Security Requirement

There is no security requirement associated with the requirement.

2. Requirement

The requirement is detailed under Annex A of the resulting contract clauses.

3. Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days of receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1. Standard Instructions, Clauses and Conditions

Revision to Departmental Name: As this solicitation is issued by Royal Canadian Mounted Police (RCMP), any reference to Public Works and Government Services Canada or PWGSC or its Minister contained in any term, condition or clause of this solicitation, including any individual SACC clauses incorporated by reference, will be interpreted as reference to RCMP or its Minister.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The 2003 (2013-06-01) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

2. Submission of Bids

Bids must be submitted only to RCMP Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

Due to the nature of the bid solicitation, bids transmitted by email to RCMP will not be accepted.

3. Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than ten (10) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the questions or may request that the Bidder do so, so that the proprietary nature of the question is eliminated, and the enquiry can be answered with copies to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

4. Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Saskatchewan.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the bidders.

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that bidders follow the format instructions described below in the preparation of their bid:

- (b) use a numbering system that corresponds to the bid solicitation.

2. Basis of Selection

A bid must comply with the requirements of the bid solicitation and meet all mandatory technical evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract. Bids will be assessed as per Annex B, Basis of Payment.

PART 5 - CERTIFICATIONS

The certifications provided by bidders to Canada are subject to verification by Canada at all times. Canada will declare a bid non-responsive, or will declare a contractor in default, if any certification made by the Bidder is found to be untrue whether during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply with this request will also render the bid non-responsive or will constitute a default under the Contract.

1. Mandatory Certifications Required Precedent to Contract Award

To supply and deliver one (1) monitor/defibrillator to the Royal Canadian Mounted Police, F Division, located in Regina, Saskatchewan, in accordance with the requirement specifications, terms and conditions detailed herein.

The monitor/defibrillator must have the following specifications:

1. LIFEPAK 15 V2 Monitor/Defibrillator or equivalent with Adaptive Biphasic, Manual and Automatic External Defibrillators (AED), Color LCD – minimum 8.4" diagonal screen, 100mm Printer with minimum print speed of 25mm/sec, Non-invasive Pacing – demand and non-demand rate, CPR Metronome, Trending, Pulse Oximetry (SpO2), Non-Invasive Blood Pressure (NIBP), 12-Lead ECG, End-tidal CO2 (EtCO2), temperature monitoring, Bluetooth capability;
2. Two (2) pair Quik-Combo Electrodes connector for pacing/defibrillation/ECG or equivalent;
3. Test Load, to perform therapy cable performance checks or equivalent ;
4. Two (2) Rechargeable Lithium-ion Batteries or equivalent rechargeable batteries to enable unit to operate without power with a minimum of 4 hours operating time and maximum charge time of 4 hours;
5. AC Power Adapter or equivalent to enable unit to operate on power only;
6. AC Power Cord or equivalent to enable unit to operate on power only;
7. Extension Cable for AC Power Adapter (Minimum 5 feet in length);
8. Pulse Oximetry Monitoring Cable (M-LNCS DCI), Adult Reusable Sensor;
9. Non-Invasive Blood Pressure (NIBP) Reusable Cuff, Large Adult;
10. Non-Invasive Blood Pressure (NIBP) Reusable Cuff, Extra Large Adult;
11. Carry case with right and left pouches and shoulder strap.
12. Able to withstand a drop from a minimum of 30 inches and water resistant for operation in rainy conditions.

**Annex C

Where weight, dimensions or other characteristics are shown as approximate, minimum or maximum, the bidder must indicate the manufacturer's figures.

1. Products that are equivalent in form, fit, function and quality to the item(s) specified in the bid solicitation will be considered where the Bidder:
