Amendment 005 is issued to make changes to Mandatory Technical Criteria 3 (MTC 3), Proposed teachers' experience, of the RFP.

Change to MTC3, Proposed teachers' experience : The changes have been highlighted

On Page 16 of 56, change MTC3, Proposed teachers' experience, by the following:

The Bidder must demonstrate that each proposed teacher in MTC2 has, since January 1, 2009, acquired at least 2,000 hours of experience in teaching French as a second language to groups of adults at the beginner, intermediate and/or advanced levels (minimum of four students per group) **AND at least 2 teachers among the 4 proposed have acquired** 140 hours of teletraining experience in teaching French as a second language to groups of adults (minimum of four students per group), using the Programme de français langue seconde (PFL2 – A, B et C) – Levels A, B and C. The Bidder must provide at least the following information for each training project for which the experience meets the requirements of evaluation criterion MTC3:

- I. the period of time over which the traditional training and teletraining experience in teaching French as a second language to groups of adults was acquired, in the following format: from (month/year) to (month/year);
- II. the number of hours of full-time and/or part-time training delivered by the teacher corresponding to the period mentioned in I);
- III. the use of PFL2 A, B and C;
- IV. the level(s) taught;
- V. the name of the client to whom training services were provided, as well as the name and current email address and/or telephone number for the client's delegated representative who could confirm the information provided by the Bidder.
