PART 1 - GENERAL INFORMATION

1. Security Requirement

There is no security requirement associated with the requirement.

2. Requirement

The Royal Canadian Mounted Police has a requirement for a firm quantity of one thousand nine hundred and ninety two (1992) Gloves, Brown, Leather, Unlined, Male.

Additionally, the requirement includes an "as and when requested" quantity (flexible stock) of up to two hundred and forty (240) regular sized Gloves, Brown, Leather, Unlined, Male, to be ordered within 24 months of contract award.

The requirement is to be supplied in accordance with RCMP Specification G.S. 1045-044 dated 2013-12-17 and viewing sample.

This requirement is conditionally limited to Canadian goods.

2.1 Optional Quantities

The Contractor grants to Canada the irrevocable option to acquire Gloves, Brown, Leather, Unlined, Male under the same terms and conditions and at the price(s) in the resulting contract. The optional quantity may only be exercised for up to a maximum of 528 pairs. The optional quantity may only be exercised by the Contracting Authority and will be evidenced, for administrative purposes only, through a contract amendment.

The Contracting Authority may exercise the optional quantity within 12 months after contract award date by sending a written notice to the contractor.

The 2003 (2013-06-01) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

2. Submission of Bids

Bids must be submitted only to Royal Canadian Mounted Police (RCMP) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

Due to the nature of the bid solicitation, bids transmitted by facsimile or by email to the RCMP will not be accepted.

3. Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than seven (7) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the questions or may request that the Bidder do so, so that the proprietary nature of the question is eliminated, and the enquiry can be answered with copies

4. Applicable Laws

Section I: Technical Bid

In their technical bid, bidders should explain and demonstrate how they propose to meet the requirements and how they will carry out the work (reference pre-award sample, Part 4, Evaluation Procedures, 1.1.1 Mandatory Technical Criteria).

Section II: Financial Bid

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

1. Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.
- (c) The evaluation team will determine first if there are three (3) or more bids with a valid Canadian Content certification. In that event, the evaluation process will be limited to the bids with the certification; otherwise, all bids will be evaluated. If some of the bids with a valid certification are declared non-responsive, or are withdrawn, and less than three responsive bids with a valid certification remain, the evaluation will continue among those bids with a valid certification. If all bids with a valid certification are subsequently declared non-responsive, or are withdrawn, then all the other bids received will be evaluated.

1.1 Technical Evaluation

The pre-award sample along with Certificates of Compliance and Component Sample swatches will be required after the bid closing date, upon a written request from the Contracting Authority, from the four (4) lowest bidders. Should the four (4) lowest bidders not be technically compliant, the next four (4) lowest bidders will be requested to submit pre-award samples, and so on until a technically compliant bid is found.

The Bidder must ensure that the required pre-award sample is manufactured in accordance with the technical requirement and are fully representative of the bid submitted. Rejection of the pre-award sample will result in the bid being declared non-responsive.

An RCMP viewing sample will be provided to bidders who are requested to provide a pre-award sample and is to be used for guidance for all factors not covered by the RCMP Specification. The RCMP Specification shall govern.

The viewing sample is not to be damaged or cut, but returned in the same condition as sent to the bidder.

The bidders must deliver the required pre-award sample, certificates of compliance and component sample swatch at no charge to Canada and must ensure that they are received within **30 calendar days** from request. Failure to submit the required pre-award sample, certificates of compliance and component sample swatch within the specified time frame will result in the bid being declared non-responsive. The pre-award sample will be evaluated for quality of workmanship and conformance to specified materials and measurements. Minor observations will not be a reason to reject the sample(s) unless, in the opinion of the technical evaluator(s), they are considered to render the item unserviceable. However, only one deviation will result in the bid being declared non-responsive.

The requirement for a pre-award sample, certificates of compliance and component sample swatch will not relieve the successful bidder from submitting sample(s), certificates of compliance and component sample as required by the contract terms or from strictly adhering to the technical requirement of this Request for Proposal and any resultant contract.

If the above has been met, the bidder must sign this representation and warrants that <u>no</u> <u>significant changes</u> have occurred in their manufacturing processes or their organization since the last award or pre-award qualification, which could affect the manufacturing of the referenced item.

Certificate of Compliance - Definition

A certificate of compliance is defined for this solicitation as a signed and dated certification by an appropriate official of the component manufacturer. (e.g. slide fastener, hook and loop, webbing, etc.) It must specifically address the adherence of the offered component to the specification or manufacturing data of the technical requirement.

A separate certificate of compliance is required for each individual product or component. It must be dated within eighteen (18) months of the solicitation posting date; and must certify that the product for which the Certificate of Compliance was issued is the same product used in the bid submission, or in the pre-award sample or in the pre-production sample, or in the production units as applicable.

The Bidder is to note that copies of invoices, purchase orders and Certificates of Compliance for products or components that are not manufactured by the certifier are not suitable for use as a Certificate.

PART 5 - CERTIFICATIONS

Bidders must provide the required certifications and documentation to be awarded a contract.

The certifications provided by bidders to Canada are subject to verification by Canada at all times. Canada will declare a bid non-responsive, or will declare a contractor in default, if any certification made by the Bidder is found to be untrue whether during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply with this request will also render the bid non-responsive or will constitute a default under the Contract.

1. Mandatory Certifications Required Precedent to Contract Award
