Amendment 002 is raised to answer Bidder's questions as follows:**Q1:**

In the RFP the Crown states: "The mandatory requirement states that the bidder must: "The Bidder must propose at least one (1) resource for each of the resource category (modelling and computer science). Each resource must have a minimum of 12 months of software development experience with the Karma software."

Will the Crown remove the requirement for the mandatory requirement for 12 month of software development experience with the Karma as the crown does allow for the bidder to become familiar with the Karma and SADM simulation environment as a task per Annex A, Section 3.1.1?

A1:

The Crown will not remove the requirement for 12 months of experience with Karma. 12 months of experience is actually very little. Karma is a very wide and complex environment and the Contractor must at least be fluent with the main services of the architecture. The task in Annex A, Section 3.1.1 to become familiar with Karma is to study in deep the mechanisms involved in the interfacing of Karma and SADM. It can be seen as the design task before developing the plugin. This task cannot be completed within the time and budget allocated without a good understanding of Karma right at the beginning. We have determined that the pre-requisite level of understanding is a minimum of 12 months of experience.

Q2:

In Attachment 2, Mandatory and Point Rated Criteria, Requirement 3.2 asks for firm's experience "in carrying out military systems-related projects (platforms, sensors, defence or attack equipment)". With the nature of the current project, would M&S projects addressing modelling and analysis of platforms, sensors, defence or attack equipment be acceptable?

A2:

Yes, M&S experience in these domains is acceptable.
