This amendment is being raised to respond to questions received during the solicitation period.

**QUESTIONS AND ANSWERS – SERIES 4**

Q1. I believe what is being asked is that there be a space (not border) of 20px or 55px between the image (the gun) and the edge of the document. In the case of the "Example of final high res.psd" sample, there is more than 55px between the edge of the document and the image. Should the document be cropped to make sure there is only an exact space of 55px between the image and the edge of the document or is there no limit to the space between the edge of the image and the document, just a restriction of no less than 55px?

A1. The statement "I believe what is being asked is that there be a space (not border) of 20px or 55px between the image (the gun) and the edge of the document", is correct. This is the minimum amount of space we require in order to prevent the image from being cropped too closely.
