Question 1 : MTC 3

Would you accept a teacher who had acquired 70 hours of experience in teletraining in 2013 and who is presently teaching another 70 hours of teletraining course (from January to March 2014), this teacher will have acquired 140 hours for the beginning of your new contract?

Answer

No. The number of hours of experience in Teletraining must have been acquired between January 1st, 2009 and the closure date of the bid. All hours which will be acquired after the closure date of the bid will not be taken into account

Question 2 : MTC 2 – Teachers' Education

We have a teacher who has acquired 140 hours of teletraining for groups using PFL2 and more than 6000 hours in teaching to groups at the CSPC and 300 hours at Stat. The teacher has a Bachelor with specialisation in mathematics. His diploma was accepted at the CSPS and Statistics in 2012-2013, could you add "mathematics" to the list of required disciplines giving that your client is mainly statisticians - mathematicians?

Answer

No, we do not accept a diploma in Mathematics. Only the disciplines indicated in MTC2 under ***Proposed teachers' education*** and their equivalent will be accepted.

"The Bidder must demonstrate that each proposed teacher in MTC2 has a Bachelor of Arts (B.A.) or a degree in education, linguistics, journalism, translation, history, political science, social sciences, theology, psychology, communications, anthropology, sociology, philosophy or literature from a recognized university or equivalent as established by a recognized academic credentials assessment service organization if earned outside Canada.
