Q1. A slim white border is visible around the gun and through the trigger hole of the Long Gun sample. Is this an anti alias and if so is that a requirement?

A1. When we make a selection we expand the selection by one pixel to make sure that none of the firearm is masked out. Provided that your selection is accurate and does not eliminate any of the firearm, this step is not required.
