Clarification to Questions:

Q1. In the spec a couple of (few) times we refer to BC such as to BC Building Code, BC workers compensation, BC licence, etc . The work takes place in Yukon, therefore an equivalent to BC need to be spec-ed including the Yukon Compensation Board, etc .. Can you check the spec and create the amendment.

A1. No BC specific requirement for seismic.

Work to be conducted outside of Owner's normal operating hours. (Section 01 11 00 Article 1.6.3)

Q2. For the quantity, the bidders need clarification what represents a " luminaire" (to be defined) – is it a fixture with two lamps, a fixture with one lamp, 4 feet, 2 feet? etc ?

If we ask for 1383 luminaires = are we referring to 1383 x 2 lamps?

A2. Number of lamps for each luminaire type are outlined in the luminaire description table in Section 1.2.4 of the specification.

Q3. Have these two lights been identified in the spec?

(a) 229 – basement

A3(a). Yes these should be included as Type 'D' - 2 Lamp 4' Striplight with Wireguard

(bi) 230 and 231 on the wall in the main hallway

A3(bi) These have not been included

(bii) Deep cell parabolic in a boardroom

A3(bii) These have not been included
