PART 1 - GENERAL INFORMATION

1. Security Requirement

There is no security requirement associated with the requirement.

2. Requirement

The Royal Canadian Mounted Police (RCMP) has a requirement for a firm quantity of 3200 Baseball caps. The breakdown of the firm quantity is as follows: 2200 Blue, 250 ERT Black, 50 Chaplain and 700 Cadet.

Finally, there is an "as and when requested" quantity of up to 10 made-to-measure Baseball caps (specials), which can be ordered within 24 months of contract award.

The requirement is to be supplied in accordance with RCMP Specification G.S. 1045-181 dated 2013-12-06 and viewing sample.

This requirement is conditionally limited to Canadian goods.

2.1 **Optional Quantities**


The Contractor grants to Canada two irrevocable options to acquire Baseball caps under the same terms and conditions and at the price(s) in the resulting contract. The two optional quantities may only be exercised for up to a maximum of 500 units each. The optional quantities may only be exercised by the Contracting Authority and will be evidenced, for administrative purposes only, through a contract amendment.

The Contracting Authority may exercise the first optional quantity within 12 months of contract award date and the second option within 24 months of contract award date by sending a written notice to the contractor.

3. Debriefings

After contract award, bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days of receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

3. Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than seven (7) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the questions or may request that the Bidder do so, so that the proprietary nature of the question is eliminated, and the enquiry can be answered with copies to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

4. Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in the province of Ontario.

PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION

1. Evaluation Procedures

- (a) Bids will be assessed in accordance with the entire requirement of the bid solicitation including the technical and financial evaluation criteria.
- (b) An evaluation team composed of representatives of Canada will evaluate the bids.
- (c) The evaluation team will determine first if there are three (3) or more bids with a valid Canadian Content certification. In that event, the evaluation process will be limited to the bids with the certification; otherwise, all bids will be evaluated. If some of the bids with a valid certification are declared non-responsive, or are withdrawn, and less than three responsive bids with a valid certification remain, the evaluation will continue among those bids with a valid certification. If all bids with a valid certification are subsequently declared non-responsive, or are withdrawn, then all the other bids received will be evaluated.

1.1 Technical Evaluation

1.1.1 Mandatory Technical Criteria

As part of the technical evaluation, to confirm a Bidder's capability of meeting the technical requirements, Pre-award samples of each the following items will be required: : **1 Baseball cap**, **Black, ERT - size S/M - RCMP stock # 2932-312, 1 Baseball cap Cadet - size S/M - RCMP stock # 2938-100, 1 Baseball cap, Blue - size S/M - RCMP stock # 2930-102 and 1 Baseball cap, Chaplain - size S/M - RCMP stock # 2935-100 along with Certificates of Compliance/Product Test Data will be required after the bid closing date, upon a written request from the Contracting Authority, from the four (4) lowest bidders.** Should the four (4) lowest bidders not be technically compliant, the next four (4) lowest bidders will be requested to submit pre-award samples, and so on until a technically compliant bid is found.

The Bidder must ensure that the required pre-award samples are manufactured in accordance with the technical requirement and is fully representative of the bid submitted. Rejection of the pre-award samples will result in the bid being declared non-responsive.

An RCMP viewing sample will be provided to bidders who are requested to provide pre-award samples and is to be used for guidance for all factors not covered by the RCMP specification. The RCMP specification shall govern.

The viewing sample is not to be damaged or cut, but returned in the same condition as sent to the bidder.

The bidders must deliver the required pre-award samples and Certificates of Compliance/Product Test Data at no charge to Canada and must ensure that they are received within **45 calendar days** (including purchase and receipt of Government Available Material) from request. Minor observations will not be a reason to reject the samples unless, in the opinion of the technical evaluator, they are considered to render the item unserviceable. Certificate of Compliance - Definition

A Certificate of Compliance is defined, for this solicitation, as a signed and dated certification by an appropriate official of the component manufacturer (e.g. slide fastener, hook and loop, webbing, etc). It must specifically address the adherence of the offered component to the specification or manufacturing data of the technical requirement.

A separate certificate of compliance is required for each individual product or component. It must be dated within 18 months of the solicitation posting date; and must certify that the product for which the certificate of compliance was issued is the same product used in the bid submission, or in the pre-award samples or in the pre-production samples, or in the production units as applicable.

The Bidder is to note that copies of invoices, purchase orders, and certificates of compliance for products or components that are not manufactured by the certifier are not suitable for use as a Certificate of Compliance.



It does not include pensions payable pursuant to the <u>Canadian Forces Superannuation Act</u>, R.S., 1985, c.C-17, the <u>Defence</u> <u>Services Pension Continuation Act</u>, 1970, c.D-3, the <u>Royal Canadian Mounted Police Pension</u> <u>Continuation Act</u>, 1970, c.R-10, and the <u>Royal Canadian Mounted Police Superannuation Act</u>, R.S., 1985, c.R-11, the <u>Members of Parliament Retiring Allowances Act</u>, R.S., 1985, c.M-5, and that portion of pension payable to the <u>Canada Pension Plan Act</u>, R.S., 1985, c.C-8.




