AMENDMENT #006

The intent of this amendment is to answer questions from potential bidders and revise Annex "A" & Annex "B-2".

Q1. Within Annex "A", under: 2.1 Specification, minimum requirements , Item #198 Cooling rack

Q1.1 The cooling racks will hold solid food trays... Could you please specify the size of the food trays.

A1.1 This cooling rack is intended for bakers cookie sheets not food trays. It must hold bun pan sized 26 inches by 18 inches, quantities of 20 full size sheet pans or 40 half size pans, with 3" of spacing between the slides.

Q1.2 What is the requested quantity?

A1.2 Requested total item quantity of 10 is indicated in the fillable spreadsheet available at: <https://buyandsell.gc.ca/procurement-data/tender-notice/PW-KIN-650-6254>

Q2. Within Annex "A", under: Item #219 Storage (Dunnage) rack

Q2.1 Could you please reconfirm the dimensions. Storage shelving (as per RFP picture) standard dimensions are:

minimum standard length : 24" (610 mm)

standard depth: 14" (356 mm), 18" (457 mm), 21" (533 mm), 24" (610 mm)

Posts standard height: 54" (1372 mm), 63" (1600 mm), 72" (1829 mm)

A2.1 The client has confirmed the correct size and weight should be: 60" high x 21" wide x 12" deep and hold up to 3,000lbs.

Q2.2 What is the requested quantity?

Q2.3 Do you need assembling and put in place?

A2.3 No, the client does not require assembly or placement.

Q2.4 Item # 219: You requested bun racks that can contain 12 trays measuring 18" x 26". In the description in the request for quote (see attachment), the storage rack measures 12" x 21" x 60" in height with 4 trays. How can 12 trays measuring 18" x 26" be stored on a rack that holds 4 trays measuring 12" x 21"?

A2.4 This question has been answered in A2.2.

Q3. Received the Base Borden quote, but something occurred to us, the request for inserts was not very clear, they asked for insert pans, but specified no gauge, either 24 gauge or 22 gauge. Since these

pans are going to be used in a very rough way, I would think 22 gauge would be best, maybe 24 gauge at the least. Could you please clarify what gauge should be used?

A3. The client requires 22 Gauge

Q4 Item #193: What is the length of the mixer required?

A4 Dimensions: 12" x 1 5/16" x 1"

Q5 Item #45: Comes in a package of 6 units.

A5 The client requires a quantity of 10 of this item

Q6 Items # 105 and 117: Comes in a package of 6 units.

A6 The client requires quantities of 25 each for items #105 and #117.

Q7 Item # 159: Comes in a package of 3 units.

A7 I require 24 each of this item

Q8. Could we get description clarification on some of the requested smallware items:

Q8.1 line 47 - cheese blocker 17" x 17 1/4" x 32"

A8.1 made of stainless steel with a Cut Size: 1/2"

Q8.2 line 59 - stainless steel scoop 52 ml

A8.2 Capacity 52 ML was put in error should read 52 Oz 1537.8 ml

Q8.3 line 77 - stainless steel measuring tools 1/4 qt

A8.3 should read stainless steel measuring cup 1/4 qt

Q8.4 line 78 - stainless steel measuring tools 4 qts

A8.4 should read stainless steel measuring cup 4 qts

Q8.5 line 89 - market trays (desserts) 10 7/16" x 3/4"

A8.5 used for displaying breads, bakery items, and sliced deli meat,

- heavy-duty fiberglass construction, with metal reinforced rods
- has air-flow corners reduce drying time;

- Q9.** Item #45 - Soup pot, 11qt: I presume this is a stock pot and not for service? If so, do you require aluminum or stainless steel? Also, do you require lids?
- A9.** No this pot is for service and will need to fit inside a soup warmer kettle. Stainless steel is required. No lids are required but will be acceptable if they are included in the set.
- Q10.** Item #81 - Mixing bowl, 24 qt
24 quart does not appear to be an available size in mixing bowls - the sizes jump from 20 quart to 30 quart. If your kitchen currently has a 24 quart bowl, are they able to provide a make and model number?
A10. If 24 Qt is not available then a 30 qt is acceptable
- Q11.** Item #156 - Shakers (complete with lids) cheese, 10 oz
Are these polycarbonate? If so, how are they different from item #157? Just the cheese-specific lid that it comes with?
- A11.** #156 is the glass shaker with the Stainless steel lid
#157 is the polycarbonate for use in the kitchen area (these are two different requirements)
- Q12.** Item #133 - Measuring jug, 4 quart
Is this aluminum, stainless steel or polycarbonate? If polycarbonate, how does it differ from Item #176
- A12.** #133 is a Stainless steel measuring jug 4 qt
- Q13.** For all Cambro polycarbonate products (food storage containers, hotel pans, etc.), are there colour specifications, or are all items clear plastic (Cambro colour code #135)?
