Amendment #005 is raised to **(A)** answer the following questions from a bidder, and **(B)** modify the Basis of Payment.

(A) To answer the following questions:

Question (1)

In the base requirement tech spec there are a couple of items listed as requirements that are also listed as optional items in Annex B.

Can you clarify if you want these items priced in the Pricing Basis "A" Initial Requirement and simply shown what the values are for those items in the Pricing Basis "B" Optional Requirements?

Or should those items not be listed in the Pricing Basis B Optional Requirements (since they are already part of the base system).

A4-15 The cutting head must have a mechanical pierce assist device for piercing optimization of exotic, fragile, laminated and brittle material. This must be tied directly into the controller for automatic operation. The pierce assist device must be able to pre-pierce materials such as stone, glass, and composites up to 152 mm (6") thick. This device must not simply be pump pressure control (i.e. low pressure pierce ramping to high pressure). Also, a side drill cannot be accepted due to the potential material thickness and hardness.

Same as (from Pricing Basis B, Optional Requirements),

1 Piercing system to create holes in brittle and composite materials without breakage or delamination.

A4-22 System must include a separate weir or over/under style final filter for the overflow effluent prior to discharge down the drain. The effluent discharge limits must be within the values stipulated in the City of Hamilton, Sewer Use By-Law. The filter system must have a sump pump along with filters ensuring clean water only is discharged down the drain.

Same as (from Pricing Basis B, Optional Requirements),

4 Water filtration system to ensure discharge of minimum contaminant levels.

Answer: The price for 4-15 and A4-22 must be included in Pricing Basis "A". The Optional Requirements for items # 1 and #4 will be removed from the Basis of Payment, see (B) below:

Question (2) We manufacture several series of machines.

In the case of this bid, one series satisfies all the requirements for the Pricing Basis A – Initial Requirement.

However, we do not have a taper compensation system option for that series as requested in Pricing Basis B – Optional Requirements

6 Taper compensation: mechanical taper correction system on the cutting head (i.e. 5 axis type) to eliminate the natural tapers created by the water jet on thicknesses up to 4 inches. The taper compensation must be fully automatic and controlled by the software

For that option only we would have to quote our alternative series waterjet. Everything else is fine.

I should also note that the alternative series has everything that other series has plus the ability to upgrade to the taper compensation (and a few other items that exceed the requirements of the base bid).

But the alternative series would have a higher price to start with.

Can I provide our bid the following way....?

- Provide the bid and Pricing Basis A Initial Requirement for one series of waterjet.
- Then for the Taper Compensation system provide a base price for the alternative series waterjet machine (base that also satisfies the Pricing Basis A + the optional price to add the taper compensation head)
- Then at the end of the primary technical bid demonstrate the differences between the two series and how they apply to the base technical spec (only about 2-3 items would be different but better than base requirement)

Please let us know. I am hoping we do not have to submit two completely separate bids because of this.

Answer: The model offered in Pricing Basis "A" - Initial "Requirement" must be upgradeable to the optional Requirements requested in Pricing Basis "B". Please see (B) below:
