This amendment gives effect to the following changes:

1. QUESTIONS AND ANSWERS:

Q1. Drawing A8, “section 4/A2”, Note “Replace and/or patch concrete floor as require”. Are we permitted to carry a unit rate for concrete as the extent to this item is unknown?

A2. No, the amount of concrete required to complete the installation of new plumbing and electrical is easily estimated. Any unforeseen quantities will be dealt with during construction.

Q2. Drawing A3, “Second Floor Plan – New”, Note “Reinstate Window”. Are there any further specifications or details available on this note?

A2. the window frame is intact just have to install new thermopane window to suit.

Q3. Drawings A2, A7 & A8, all notes pertaining to wood to be used in staircase, railings, wainscoting, sills and nosing. Please confirm type of wood to be used on each.

A3. All finished wood ie: stair treads, risers, wainscoting, nosing, sills etc. are to be maple finish to be chosen during construction.

Q4. In Addendum #3 it is stated that measurements for the existing windows to be covered with Lexan panels are not available at this moment. Without dimensions, and seeing that there are multiple sizes and shapes of windows, it is difficult to provide an accurate quotation without knowing the quantities of Lexan panels and the number of stainless steel brackets needed to hold them in place. Will this information be made available before the tender closing?

A4. Parks staff is not currently available to take these measurements. The exterior of the building is readily accessible for measuring. Please refer to drawing A7 for quantities of brackets
