AMENDMENT 7

Please see the following questions and answers:

Q1: In MTC point 2.3.2, there is are lists of information the Offeror is requested to provide regarding pedagogical advisers whether they are being proposed under mandatory criterion 2.3.1 a) or 2.3.1 b). In both lists, there is a point stipulating that the Offeror must provide: "One or more certifications signed by the current employer or previous employer(s) confirming the experience cited in i and ii."

a) Given the small number of potential offerors in any given geographical area, we are concerned about a potential conflict of interest arising from the fact that one or several of a proposed pedagogical adviser's previous employers may also be submitting proposals for this RFSO.

In the event that a former employer of a proposed pedagogical adviser is unwilling to sign a certification, we wish to know if this would preclude us from proposing that particular resource or if there would be another way to confirm a proposed adviser's experience.

A1: If such an event was to occur, a formal affidavit duly signed by the proposed pedagogical adviser confirming the experience cited in i and ii would be acceptable.

Q2: b) Further to this question, we wish to know what the procedure is for certifications from resources who have been self-employed. Can a self-employed adviser sign his or her own certification, provided that he or she includes the required references?

A2: A formal affidavit signed by the self-employed adviser confirming the experience cited in i and ii would be acceptable.

All other terms and conditions remain unchanged.
