REASON FOR AMENDMENT:**1. Respond to the following questions raised by the industry.**

Q6. Can the 100KM be increased, with prior approval for training?

A6. Canada has reviewed the request and the requirement remains unchanged.

Q7. Can the 100KM be increased, with prior approval, for regional supervision?

A7. Canada has reviewed the request and the requirement remains unchanged.

Q8. When will we be able to have a maximum bid amount in order to meet the Financial Capability Requirement? Or will an amount be provided to us?

A8. There is no maximum bid amount for this requirement. Q9. Is there a specific amount that can be allocated to accounting fees or an independent audit?

A9. The fixed hourly rate must include professional fees and any other cost element required to provide Integrated Chaplaincy Services as described in the Statement of Work.

Q10. We are aware that there is presently a contract in place for some of the Chaplaincy Services required by the Correctional Services Canada. However, we notice that the number of hours required in the present RFP is substantial. Could you please explain the formula used to obtain these hours and if they include those TA's which have been awarded and filled by the contract presently in place and active?

A10. Given the recent transition from a multi-contract model to the proposed single contract model where all institutional chaplaincy services are provided, the estimates provided in the RFP were made to account for inclusion of all the anticipated chaplaincy demands and therefore represent an increase in comparison to the current contract model.
