.1 PART 6 - SECURITY AND INSURANCE REQUIREMENTS

1. **Security Requirement**, delete existing sentences 1 and 2 and replace with new sentences 1 and 2 as follows:

"1. Proponents are hereby informed that there is a strong possibility that some call-ups against the Standing Offers might require that the consultants and their personnel possesses a Facility Security Clearance (FSC) at the RELIABILITY level issued by the Canadian Industrial Security Directorate (CISD) of Public Works and Government Services Canada (PWGSC). Call - ups at Correctional Services Canada facilities may require CPIC clearance for personnel visiting their sites.

Should the successful proponents not have the level of security indicated above, PWGSC shall sponsor the successful proponents so CISD can initiate procedures for security clearance. CISD, by letter, shall forward documentation to the successful proponents for completion.

Proponents desiring such sponsorship should so indicate in their covering letter with their proposal.

2. Successful proponent(s) issued a standing offer as a result of this RFSO, not possessing the required security clearance at time of call up, will be bypassed and PWGSC will proceed to the next consultant who possesses the required security clearance and it is furthest away from the ideal business distribution. Refer to the Standing Offer Particulars for information regarding ideal business distribution."

.2 PART 7 - STANDING OFFER AND RESULTING CONTRACT CLAUSES

A. STANDING OFFER

2. **Security Requirement**, delete existing sentences 1 to 4 and replace with new sentences 1 to 5 as follows:

"1. If required by the call - up, the Offeror must, at all times during the performance of the Contract, hold a valid Designated Organization Screening (DOS), issued by the Canadian Industrial Security Directorate (CISD), Public Works and Government Services Canada (PWGSC).

2. If required by the call - up, the Offeror personnel requiring access to sensitive work site(s) must EACH hold a valid RELIABILITY STATUS, granted or approved by CISD/PWGSC, and CPIC clearance at CSC facilities.

3. If required by the call - up, the Subcontracts which contain security requirements are NOT to be awarded without the prior written permission of CISD/PWGSC.

4. If required by the call - up, the Offeror must comply with the provisions of the:

(a) Security Requirements Check List and security guide (if applicable), attached at Annex "D";

(b) Industrial Security Manual (Latest Edition).

5.
