The purpose of this amendment is to answer the following questions:

- **Q1.** Appendix E Security Requirements, a number of items are marked "to be completed". Are these forms required to be completed and submitted with the proposal document? Or are these only required to be submitted by the successful proponent?
- **A1.** No, they are not required with the proposal submission. Completion and submission is requested at time of award.
- **Q2.** Sections 2.2.4.2.3) and 2.6.1 Does the Peer Reviewer have to be a 3rd party from another company or can we do internal peer reviews? Does the peer reviewer also have to be licensed to practice in Saskatchewan or is a Professional Engineer/Architect from another province adequate?
- **A2.** The RFP states "as part of the design reviews we ask for documented peer reviews" and "the prime consultant will be responsible for peer reviews for each discipline and peer reviews will be completed by all disciplines and documented with responses". The peer review is to be undertaken by a Principal, or another senior staff member from the prime consultant's office that is not directly involved with the project document development. These reviews would also need to be formally documented so they could be formally tracked through the project's design progression. No licenses necessarily required.
- **Q3.** Do all documents completed under this contract have to be completed in English and French?
- **A3.** No. The deliverables under the contract would be expected to be delivered in the language of work in this province which, for the majority, and in the case of contractors carrying out the construction work, would be in English.
- **Q4.** Do the hourly rates on pages 19 and 20, that are not part of the evaluation, have to be completed and submitted with the bid? And are they for the principal's firm only?
- **A4.** Yes they must be included with the proposal, as instructed within the Submission Requirements and Evaluation of the RFP and the amended checklist included with Amendment No. 03. And yes, the hourly rates are for the principal's firm only.
