Q1.) In Part 1 – General Information, Section 2 (i) – Summary, there appears to be a requirement for the prime vendor to be an architectural firm. Would you accept prime vendors who are not registered architectural firms but instead engineering firms or facility assessment specialists with architects and engineers on staff vs. an architectural firm?

A1.) Please refer to Addendum No. 1

Q2.) Pertaining to section A 2 – Statement of Work, A 2.1 – Building Condition Reports, is the assumption correct that the paper-based reports are for facilities that currently do not exist in the AVS/CAPS database? If not, please elaborate on the scope of work required as related to paper based reports.

A2.) Yes, Paper Based and Text Based are indeed that, no electronic data based format.

Q3.) In Section A1.7 – Project Response Time, it states that the prime and sub-consultant need to be “personally available” within ½ day of a request. Can “personally available” be via phone or web conferencing, in addition to in-person?

A3.) Yes.

Q4.) In Annex F – Price Offer, there is discussion of recording hourly rates for junior, intermediate and senior professionals by different trades. Does PWGSC have a more detailed worksheet for capturing this information along with the appropriate weightings to come up with the “Weighted Hourly Rates (B)” in the Price Offer Summary Table?

A4.) No. If there is no “Architect-Prime Consultant”, equivalent P. Eng or senior company personnel will suffice.
