- "Should the contract be terminated for default, the next lowest priced, technically compliant bidder may be considered"
- \* Please note this sentence was not put in the French RFP.

- (a) If the first pre-production sample is rejected, the contractor must submit the second preproduction sample within <u>21 calendar days</u> of notification of rejection from the Technical Authority.
- (b) The Technical Authority must notify the Contractor, in writing, of the conditional acceptance, acceptance or rejection of the sample(s). A copy of this notification is to be provided by the Technical Authority to the Contracting Authority. The notice of conditional acceptance or acceptance must not relieve the Contractor from complying with all requirements of the specification(s) and all other terms of the Contract.
- (c) The Contractor must not commence or continue with production of the items and must not make any deliveries until the Contractor has received notification from the Technical Authority that the samples are acceptable. Any production of items before sample acceptance will be at the sole risk of the Contractor.
- (d) Rejection by the Technical Authority of the second pre-production samples submitted by the Contractor for failing to meet the contract requirements will be grounds for termination of the Contract for default.

**DELETE:** Should the contract be terminated for default, the next lowest priced, technically compliant bidder may be considered.

#### 17. Definitions

#### 17.1 Certificate of Compliance - Definition

A Certificate of Compliance is defined, for this solicitation, as a signed and dated certification by an appropriate official of the component manufacturer (e.g. slide fastener, hook and loop, webbing, etc). It must specifically address the adherence of the offered component to the specification or manufacturing data of the technical requirement.

A separate certificate of compliance is required for each individual product or component. It must be dated **within 18 months** of the solicitation posting date; and must certify that the product for which the Certificate of Compliance was issued is the same product used in the bid submission, or in the pre-award samples or in the pre-production samples, or in the production units as applicable.

The Bidder is to note that copies of invoices, purchase orders, and Certificates of Compliance for products or components that are not manufactured by the certifier are not suitable for use as a Certificate of Compliance.

#### 17.2 Test Report – Definition

Test report document shall include the test methods, test conditions and test results performed by an independent, third-party accredited laboratory acceptable to the RCMP to verify requirements as specified in this specification.
