The purpose of this amendment is to answer the following questions:

Q14. Can Page 1 of any amendments be signed/initialed and submitted via fax?

A14. *Yes, as long as the proponent is clearly identified on the fax submission and it is received prior to the closing date and time.*

Q15. If an amendment causes the proponent to change their bid, can a revision to the bid price be submitted by fax?

A15. *No, a price proposal cannot be submitted by fax as the prices are not opened until after the technical evaluation is completed and, if the mandatory is not met or the technical evaluation not passed, the price proposals are not opened at all. The price proposal would need to be submitted via courier by the closing date and time. If submitting a revised price proposal, the outside of the price proposal envelope would need to state that this is a replacement for the price proposal already submitted.*

A16. If based on an amendment, the proponent wishes to change both the technical proposal and the price proposal, can the technical proposal changes be submitted by fax?

A16. *No, the entire package would need to be re-submitted, with the envelope marked as a replacement to the package already submitted.*
