Solicitation amendment 001 is raised to update the Standard Instructions 2003 and the General Conditions 2010A.

Public Works and Government Services Canada (PWGSC) is updating the Integrity Provisions surrounding its procurement and real property transactions. The updated provisions include new offences and similar foreign offences, establishment of a Time Period within which convicted suppliers will be ineligible to do business with PWGSC, and extension of the Integrity Provisions to subcontractors.

The Request for Proposal is amended as follows:

1. At "Table of Content"

Delete: "Mandatory Certifications Required Precedent to Contract Award"

Insert:

"Certifications Required Precedent to Contract Award"

2. At Part 2 - Bidder Instruction, Article 1, Standard Instructions, Clauses and Conditions:

Delete: Part 2, Article 1, in its entirety, and

Insert:

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the *Standard Acquisition Clauses and Conditions Manual* (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The 2003 (2014-03-01) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

Subsection 5.4 of 2003, Standard Instructions - Goods or Services - Competitive Requirements, is amended as follows:

Delete: sixty (60) days

Insert: ninety (90) days

PART 5 - CERTIFICATIONS

Bidders must provide the required certifications and associated information to be awarded a contract.

The certifications provided by bidders to Canada are subject to verification by Canada at all times. Canada will declare a bid non-responsive, or will declare a contractor in default in carrying out any of its obligations under the Contract, if any certification made by the Bidder is found to be untrue whether made knowingly or unknowingly, during the bid evaluation period or during the contract period.

The Contracting Authority will have the right to ask for additional information to verify the Bidder's certifications. Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority may render the bid non-responsive or constitute a default under the Contract.

1. Certifications Required Precedent to Contract Award

1.1 Integrity Provisions - Associated Information

By submitting a bid, the Bidder certifies that the Bidder and its Affiliates are in compliance with the provisions as stated in Section 01 Integrity Provisions - Bid of Standard Instructions 2003. The associated information required within the Integrity Provisions will assist Canada in confirming that the certifications are true.

1.2 Federal Contractors Program for Employment Equity - Bid Certification

By submitting a bid, the Bidder certifies that the Bidder, and any of the Bidder's members if the Bidder is a Joint Venture, is not named on the Federal Contractors Program (FCP) for employment equity "FCP Limited Eligibility to Bid" list (http://www.labour.gc.ca/eng/standards_equity/eq/emp/fcp/list/inelig.shtml) available from Employment and Social Development Canada (ESDC) - Labour's website.

Canada will have the right to declare a bid non-responsive if the Bidder, or any member of the Bidder if the Bidder is a Joint Venture, appears on the "FCP Limited Eligibility to Bid" list at the time of contract award.

4. At Part 6 - Resulting Contract Clauses, Article 3, clause 3.1 - General Conditions:

Delete: Clause 3.1 in its entirety, and

Insert:

3.1 General Conditions

2010A (2014-03-01) General Conditions - Goods (Medium Complexity), apply to and form part of the Contract.

5. At Part 6 - Resulting Contract Clauses, Article 8, clause 8.1 Compliance:

Delete: Clause 8.1 Compliance, in its entirety, and

Insert:

8.1 Compliance

The continuous compliance with the certifications provided by the Contractor in its bid and the ongoing cooperation in providing associated information are conditions of the Contract. Certifications are subject to verification by Canada during the entire period of the Contract. If the Contractor does not comply with any certification, fails to provide the associated information, or if it is determined that any certification made by the Contractor in its bid is untrue, whether made knowingly or unknowingly, Canada has the right, pursuant to the default provision of the Contract, to terminate the Contract for default.

6. At Part 6 - Resulting Contract Clauses, Article 10 - Priority of Documents:

Delete: (b) the general conditions 2010A (2013-04-25) - Goods (Medium Complexity);

Insert:

(b) the general conditions 2010A (2014-03-01) - Goods (Medium Complexity);

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED
