This Solicitation Amendment 005 is raised to provide responses to questions asked at the bidders' conference dated March 6th, 2014, and to provide responses to further questions received.

All other terms and conditions remain unchanged.

Q1.) Besides Correctional Services Canada (CSC), will there be call-up work from other government departments?

A1.) Yes, the resulting Standing Offer is applicable to all PWGSC client departments.

Q2.) What is the security level required?

A2.) Refer to Addendum No. 1. Reliability Status security clearance granted by CISC of PWGSC, and / or CPIC security clearance granted by Correctional Services Canada may be required.

Q3.) Discipline question re: Elevator Specialist?

A3.) Firm specific. The consultant have the option of using an Elevator consultant, an Electrical Technician, a Mechanical Technician, or all of the aforementioned.

Q4.) Will CAPS-AVS Training be provided to the winning offerors?

A4.) Yes.

Q5.) Will CAPS-AVS software be provided to the winning offerors?

A5.) Yes.

Q6.) In reference to Addendum No 1, under PART 7 - Standing Offer and Resulting Contract Clauses, paragraph 2.3 "If required by the call-up, the subcontracts which contain security requirements are NOT to be awarded without prior written permission of CISC/PWGSC". Please clarify.

A6.) The security requirements identified in each call-up are also applicable to the sub-consultants when sub-contracts exist. In cases where RELIABILITY security status is required, the sub-consultants must also possess the requested security level granted by CISC of PWGSC before a call-up will be awarded.

Q7.) What will be the call-up limitation amount?

A7.) As per RFSO, the call-up limitation amount is \$440,000.00 (Applicable Tax Included).

Q8.) Will PWGSC sponsor proponents for CISD to initiate procedures for security clearance.
A8.) Yes.

Q9.) How many firms will be awarded the Standing Offer?

A9.) As per RFSO, it is PWGSC's intention to authorize up to two (2) Standing Offers.

Q10.) How many copies of the proposal is required for the tender submission?

A10.) One original technical proposal plus 5 copies, and one completed & signed Annex F - Price Offer.

Q11.) In reference to the subject RISO, can you please confirm that only 2 pages are allowed for the response to Annex E – 3.2.1? Based on what is being asked for, 2 pages does not seem adequate enough to address the 7 bullet points listed, in a concise and sufficient manner.

A11.) The reference of two (2) pages is for recommendation only. However, please be reminded that the maximum number of pages (including text and graphics) to be submitted for the Rated Requirements under SRE 3.2 is twenty (20) pages.
