The following changes in the bid documents are effective immediately. This addendum will form part of the contract documents.

This amendment 002 is raised to answer the following questions:

	Question	Answer
1	We do not recommend stone Mastic Paving due to the time of the year, size of the job and compaction ability. We recommend HL3 or HL3F PG 58-28 due to the finish?	Bid as per plans and specification section 32 12 18 paragraph 2.1.
2	Do we have to pay for our equipment and trucks to park on site?	Bid as per specification section 01 00 10 paragraphs 15.6 and 16.1.
3	How far is the storage facility with the lime stone pavers?	See Addendum #2.
4	Where do we cut the pavers if we can't cut them in the storage areas?	Refer to drawing L002 note #4.
5	Where do we re-route the pedestrians and what kind of structure is required?	Refer to drawing L002 note #9 for pedestrian bypass route. For signage, refer to specification section 01 00 10 paragraph 19.1 and 19.2.
6	Where do we store the site office and washroom?	For the site office, refer to specification section 01 00 10 paragraph 15.8. For the washroom, refer to specification section 01 00 10 paragraph 15.5.
7	What kind of testing are you going to do and who is paying for it?	Refer to specification section 01 00 10 paragraph 29.1.
8	What happens if there is still frost in the ground. Do you pay extra for heating and tarping?	See Addendum #2.
9	After discussing the proposed Mastic mix with our suppliers we have been notified that the product specified is not available in such small quantity. Furthermore as discussed at the site visit the Mastic	Bid as per plans and specification section 32 12 18 paragraph 2.1.

	asphalt is not workable by hand and thus not an optimal choice for this application. Please advise as to whether another asphalt mix will be acceptable for this project and how we should proceed during the bidding phase.	
10	<p>As per the conversation on site at the job showing I would like to encourage the consultant to change the requirement for stone mastic asphalt on this project for the following reasons.</p> <p>While being an excellent product and providing great friction for heavy traffic volume areas it will be overkill on a pathway.</p> <p>It is not readily available from the manufacturers in the city and asphalt cannot be transported feasibly over great distance if it was available elsewhere</p> <p>It is only Dolomite stone and juice and it will not finish properly by hand, it will appear very segregated, (normal mixes have this same issue but this is worse, it has no sand or fines to aid in compaction).</p> <p>It needs to be broken down with a wobbily wheel first and this equipment will not fit on the pathway, it is placed in reverse from normal asphalt.</p> <p>It requires a ten ton vibrating roller at least and this will also not fit and given the nature of the product, compaction will not be achievable.</p> <p>The mix design may not be readily available (and there is none in the spec 58-34, 68-34, 70-34) the supplier may not have the proper liquid asphalt in stock at the time of requirement</p> <p>There are many high end superpave materials up to level C 58-34 9.5mm stone that will give you a better finish and reliability.</p> <p>And finally the cost with application would be triple.</p>	Bid as per plans and specification section 32 12 18 paragraph 2.1.

SPECIFICATIONS

- 1 Section 01 00 10 - General Instructions
Add new article 36 as follows: "Disposal - Dispose of or recycle all 92 pallets".
- 2 Section 01 00 10 paragraph 33.2
Delete: "Obtain limestone paving and curbs from Departmental Representative's storage facility in the National Capital Region, and transport to site."
Insert: "Obtain limestone paving and curbs from Departmental Representative's storage facility at 1770 Chemin Pink, Gatineau, QC and transport to site."

- 3 Section 01 00 10 - General Instructions
Add new article 37 as follows: "Frost Conditions – Allow for temporary heating necessary to thaw any frozen ground to carry out work in order to complete the contract in the specified period."
