QUESTIONS AND ANSWERS:

Q1. What was the estimated number of pages that were transcribed last year?

A1. The total number of pages that were transcribed during fiscal year 2013-14 was approximately 8,500 pages.

Q2. Is this only for transcription or does it include the registration of intervenors?

A2. The incumbent is not expected to register intervenors.

Q3. Does the contractor have to be located in Alberta to be awarded this contract?

A3. There is no requirement for the incumbent to live in Calgary, but they must be able to travel across Canada, including to northern locations.
