Question from suppliers and answers from Canada.

A. Question #1

Clarification is required Annex "A", Requirement, 1.1 General Requirements, "Delivery of Frozen Products" it's stated that "Frozen products must not have been frozen for longer than 90 days since the date of processing in the fresh state" The cross section of frozen fruit and vegetable typically fall into a once a year pack and in most cases in order to ensure a regular supply to the industry there is usually an overlap of the seasons as we move from one pack year to another. It is not out of the ordinary to be receiving product like frozen peas etc that may have been processed in excess of 12-15 months prior.

Answer #1

"Frozen products with Out (of) Code Date - **OCD** must be no less that 90 days from the time of receipt."

B. Reference : Annex A, Requirement, 1.1, General Requirements, Delivery of Frozen Products

Delete : In it's entirety

Insert: Frozen products must be delivered in accordance with Canadian Food Inspection Agency requirements stipulating that frozen products must be maintained at -18° C or lower and fresh chilled products between 4° C and 1° C until delivery. All fresh chilled or frozen products must be delivered in refrigerated vehicles and show no evidence of deterioration. "Frozen products with Out (of) Code Date - **OCD** must be no less that 90 days from the time of receipt."
