REMOVE "Contractors will present with their Tender, a list of the equipment they propose to use for the Contract" and **REPLACE WITH** "Prior to award of Service Contract, Contractors will present a list of the equipment they propose to use for the Contract".

Paragraph 3.4.5

REMOVE "The Contractor must have a minimum of 2 years proven experience as a grass contractor and shall provide references of previous contracts upon request" and **REPLACE WITH** "The Contractor must have a minimum of 3 years proven experience as a grass contractor and shall provide references of previous contracts upon request"

DELETE "The 2003 (2013-06-01) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation" and **REPLACE WITH** "The 2003 (2014-03-01) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation" .

1.2 Federal Contractors Program for Employment Equity - Bid Certification

By submitting a bid, the Bidder certifies that the Bidder, and any of the Bidder's members if the Bidder is a Joint Venture, is not named on the Federal Contractors Program (FCP) for employment equity "FCP Limited Eligibility to Bid" list (http://www.labour.gc.ca/eng/standards_equity/eq/emp/fcp/list/inelig.shtml) available from Employment and Social Development Canada (ESDC) - Labour's website.
